

EXPLANATORY NOTE

These two draft regulation proposals are aimed at :

- fixing the threshold price for olive oil for the 1977/78 marketing year;
- renewing for the 1977/78 marketing year the principles for which subsidies, as set out in Article 10 of Regulation No 136/66/EEC, are granted to olive oil producers.

These concern regulations for the marketing year which is no way differ from such regulations adopted in previous marketing years.

fixing the threshold price for olive oil for the 1977/78 marketing year

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organization of the market in oils and fats $^{(1)}$, as last amended by Regulation (EEC) No 1707/73 $^{(2)}$, and in particular the second paragraph of Article 4 thereof,

Having regard to the proposal from the Commission,

Whereas the threshold price must be fixed in such a way to be enable the selling price of the imported product, at the frontier crossing point referred to in Article 13 (2) of Regulation No 136/66/EEC, to be maintained at the level of the market target price;

Whereas, when the costs currently incurred by the importer from the cif stage are taken into account, the level of the threshold price should be fixed at three units of account below the level of the market target price,

HAS ADOPTED THIS REGULATION:

Article 1

The threshold price for olive oil for the 1977/78 marketing year shall be 138.91 units of account per 100 kilograms.

Article 2

This Regulation shall enter into force on 1 November 1977.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Proposal for a COUNCIL REGULATION (EEC)

amending Regulation (EEC) No 3209/73 on the subsidy for olive oil

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organisation of the market in oils and fats $^{(1)}$, as last amended by Regulation (EEC) No $1707/73^{(2)}$, and in particular Article 10 (2) thereof,

Having regard to Council Regulation No 162/66/EEC of 27 October 1966 on trade in oils and fats between the Community and Greece (3), and in particular Article 8 thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 3209/73 of 27 November 1973 on the subsidy for olive oil (4), as amended by Regulation (EEC) No 2597/76 (5), laid down the principles whereby the subsidy referred to in Article 10 of Regulation No 136/66 EEC should be granted to olive oil producers for the 1973/74, 1974/75, 1975/76 and 1976/77 marketing years; whereas these principles should also cover the 1977/78 marketing year,

HAS ADOPTED THIS REGULATION :

Article 1

In Article 1 of Regulation (EEC) No 3209/73 the phrase 'For the 1973/74, 1974/75, 1975/76 and 1976/77 marketing years' shall be replaced by 'For the 1973/74, 1974/75, 1975/76, 1976/77 and 1977/78 marketing years'.

Article 2

The second paragraph of Article 2 of Regulation (EEC) No 3209/73 shall be replaced by the following:

"When the cultivation declarations have already been submitted during preceding "marketing years, they may likewise be considered valid for the 1977/78 marketing "year except if the producer"s farm has undergone such changes as would alter "its potential for producing olives and oil."

Article 3

This Regulation stall enter into force on 1 November 1977.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
