Subject: Report on the opening, allocation and management of the Community tariff quota in 1976 for frozen beef and veal falling within Common Customs Tariff heading No 02.01 A II (a) 2

Article 6 of Council Regulation (EEC) No 3288/75 of 16 December 1975 opening, allocating and providing for the administration of a Community tariff quota for frozen beef and veal falling within subheading 02.01 A II (a) 2 of the Common Customs Tariff (1976) provides that the Commission shall, not later than 1 October 1976, submit to the Council a report on the quantities for which licences have been issued in each Member State and that the Council, acting by a qualified majority on a proposal from the Commission, shall reallocate any unused quantities.

The information at present available to the Commission shows that:

- as of the end of September 1976 import licences have been allocated to traders in respect of almost 100% of the tariff quota;
- ones the period 1 January to 31 August 1976 licences have been actually issued for a total of 39 599 tonnes, expressed in bone-in meat, namely 80% of the total quantities provided for;
- at the 274th meeting of the Management Committee for Beef and Veal representatives of the Member States stated that the licences for the quantity outstanding would be issued between now and the end of the year.

For these reasons the Commission considers it unnecessary to make any re-allocation of the quota.
