Editorial

The second year of activity of the European Community Studies Association has already been marked by a number of major developments. Chief among these was the resounding success of the inaugural Conference on "The European Community in the 1990s: Emerging Concepts and Policies," held at George Mason University, Fairfax, Virginia, on May 24-25, 1989. There were 260 registered participants in the Conference and approximately 460 people attended. There were 42 panels and workshops on a wide variety of topics, two lunches with keynote speakers (Eugene McAllister, Assistant Secretary of State for Economic and Business Affairs on the first day and Professor Werner J. Feld, University of Colorado at Colorado Springs, on the second day), and a banquet with a keynote address by Sir Roy Denman, Head of the Delegation of the Commission of the European Communities. Several of the panels were taped by C-Span and appeared on national television the week following the Conference.

The Association's Constitution was overwhelmingly ratified by the membership and entered into force on May 24, 1989 at the first Business Meeting. Also at the Business Meeting results of the elections for the first Executive Committee, which will serve a two-year term, were announced. The five members are Roy H. Ginsberg (government, Skidmore), Leon Hurwitz (political science, Cleveland State), Pierre-Henri Laurent (history, Tufts), Donald J. Puchala (political science, South Carolina), and Glenda G. Rosenthal (political science, Columbia). The new Executive Committee, at a meeting on May 25, named Desmond Dinan (history, George Mason) Administrative Director of ECSA and an ex officio member of the Executive Committee. Leon Hurwitz was appointed Secretary-Treasurer.

The first formal meeting of the new Executive Committee was held at Tufts University at the end of June. In accordance with the Constitution, the Committee named Glenda G. Rosenthal to be the first Chair of the Association (1989-90) and Roy H. Ginsberg as Chair-Elect (1990-91). The Committee considered a long list of agenda items

mostly dealing with proposed future activities and the preparation of a funding proposal to submit to interested foundations. Now that the Association has a membership of 350, a publication which serves as a source of information and networking among scholars of the European Community worldwide, and has held a conference which drew a larger attendance than that of any other organization in the United States devoted to European studies, ECSA wishes to establish itself in a less ad hoc, voluntary manner. The Association hopes to set up a permanent administrative headquarters at George Mason University and obtain the assurance of ongoing financial stability.

The Executive Committee agreed to continue publication and distribution of the Newsletter and expand it in both scope and volume. Association members expressed an interest at the Business Meeting in a Newsletter which contains short articles, book reviews, teaching aids (e.g., syllabi) in addition to more materials in the categories already covered. If adequate funds are obtained, the Newsletter could well double in size over the short term. In line with this projected diversification, the present issue of the Newsletter is the last Roy Ginsberg and Glenda Rosenthal will edit. Alan W. Cafruny (government, Hamilton College) and Joseph C. Rallo (political science, Michigan Technological University) have generously agreed to take over from them. Leon Hurwitz will remain as Co-Editor and the Newsletter will continue to be produced and distributed through Cleveland State University.

Also in the realm of ECSA publications, Roy Ginsberg (assisted by Karsten Geier) is working on the compilation of a membership directory for the Association. This should be available free of charge to ECSA members before the end of the year. Also, there are plans to bring out a volume on *The State of the European Community* and publish the abstracts of the papers presented at the Inaugural Conference under the editorship of Desmond Dinan. Finally, the Executive Committee started planning a workshop on Europe's relations with the Third World, to be held in 1990, continued page 2...

GOVERNING EUROPE

The Center for European Policy Studies (CEPS) will hold its annual conference in Brussels on November 29-December 1, 1989. PROFESSIONS AND PUBLIC AUTHORITY: HISTORICAL AND COMPARATIVE PERSPECTIVES

ORGANIZATIONS, INSTITUTES, AND COURSES

CENTER FOR EUROPEAN COMMUNITY STUDIES, GEORGE MASON UNIVERSITY

On October 24, 1989, Governor Gerald Ballies of Virginia will officially open George Mason University's Center for European Community Studies, the first of its kind in the United States. Mr. Andreas van Agt, the newly-arrived Head of the EC Delegation in Washington, will attend the ceremony as one of his first official functions in this country. The Center is located in Arlington, approximately five blocks from the University's Metro Campus. Facilities include offices, a conference room, a library area, and classrooms.

The Center is a joint initiative of the School of Business Administration and the College of Arts and Sciences. Its purpose is to promote teaching and research on the European Community in the University, and to provide information and analysis to regional businesses, law firms and consultants working on EC issues. The European Community has designated George Mason University a European Documentation Center (EDC). The EDC—com-

prising EC official documentation and providing access to EC databases — will be housed in the Center for European Community Studies' library area. In order to fulfill its outreach function to the business and legal communities, the Center will launch an EC Information Service in early 1990.

The Center will also house ECSA's administrative headquarters. ECSA members are welcome to visit the Center, and make use of its research facilities.

BOOK REVIEWS

George N. Yannopoulos, editor, *European Integration* and the *Iberian Economies* (London: Macmillan Press, 1989), 308 pp.

This work represents a collection of papers relating generally to the recent entry and phased integration of Spain and Portugal into the EC. Although no one paper can be considered seminal, a full reading of the book delivers some careful empirical analysis, some well presented historical evaluation of previous trade agreements with the EC, some well supported suggestions for policy, and some nicely reasoned speculative analysis of the potential impact of EC accession on Spanish and Portuguese growth and employment. Yannopoulos provides two chapters that go beyond the basic editorial job by supplying thoughtful theoretical structure to the debate. If there is any weakness to this generally balanced collection, it is in the relatively light attention paid to the impact of EC policy integration beyond the customs union.

At the risk of ignoring other contributions, several important points bear emphasis. Yannopoulos argues succinctly and effectively that LDCs can gain by pursuing outwardly-directed development strategies with selected geographic groups of partner countries, and relates this suggestion to Spanish and Portuguese accession. Mendes and Thirlwall make a very important point regarding the influence of IMF-type stabilization programs on the structure of export development, that is, away from potentially high growth (i.e., high world income elasticity) products. Unfortunately, their point is not, at least here, clearly enough made nor substantiated to justify the policy prescriptions they make for Portugal.

Da Silva gives a careful, detailed econometric evaluation of the effects of the earlier free trade agreement between the EC and Portugal evidencing the virtually neglible export expansion effect from the agreement, and draws conclusions for the diversification of production for export along intra-industry lines, emphasizing capital and skilled labor.

Taveira, using results from prior research and a plausible scenario of the impact of full EC membership, draws a pessimistic conclusion on attracting foreign direct investment into Portugal; while Donges and Schatz demonstrate little net positive effect of accession for either output or employment in Spain or Portugal.

In sum, this work holds more than adequate rewards for anyone concerned with the implications of the expansion of the integration process beyond Northern Europe.

Guy de Bassompierre, Changing the Guard in Brussels: An Insider's View of the EC Presidency (New York: Praeger, 1988), 162 pp.

Guy de Bassompierre has held various positions in the Belgian foreign office. Drawing on this experience, he provides an excellent account of "an insider's appraisal of the institutions of the EC." He opens his account with an explanation of why the six monthly Council Presidency "symbolizes the very essence of the EC." This is that EC activities are marked less by a zero-sum transfer of competences from the nation state to supranational institutions, like the Commission or the European Parliament, and more by a pooling of sovereignties among member states and by maintenance of national control. The Presidency provides one of the mechanisms through which national representatives interact. This results in the emergence of sub-structures of the Council of Ministers which, to some extent, run parallel to the Commission's structure and challenges the latter's role. A more complex EC decision-making system has thus emerged in which the Presidency, more by default than by design, has become a key actor; e.g., as a mediator in EC decisionmaking, as an initiator on EPC issues, and as a spokesman in EC external affairs.

In subsequent chapters, de Bassompierre ranks the different Councils according to to political weight; e.g., the General Affairs Council is of prime importance, and proceeds to describe eloquently the structures and working methods of these various councils. This is the nucleus of the book, consisting of meaningful details and valuable insights into a hitherto largely unknown or secretive part of EC decision-making involving (a) the agenda setting for Council decisions; (b) the styles adopted in achieving compromise or consensus in Council decisions; and (c) the indigenous and exogenous factors which foster or hinder the role of the Presidency.

Further sections of the book deal with EPC and European security, the European Council, and the relationship between the Presidency and the European Parliament. The final section looks at the presidential team, the role the Presidency plays in relations with the United States, and the future of the Presidency. The book also provides a useful appendix on the EPC structure.

The picture which de Bassompierre provides is that whilst a Presidency offers the opportunity to raise the profile of

a given country, government or leader, the constraints of time and diverging national interests on most EC issues limit the scope and achievement of a Presidency. Further studies might penetrate deeper into the question of impact; e.g., to explore whether the Presidency can be seen more as a tool to promote national interests than as an instrument to undermine the strength of the nation state. Altogether, this is a valuable book which will make an important contribution to our understanding of the Presidency and of EC decision-making.

Emil Kirchner (Essex) is conducting research on the EC Council Presidency in order to analyze the impact of the Presidency on the process of integration. His research is expected to result in a book entitled Decisionmaking in the European Community: The Council Presidency and European Integration (Manchester, 1991).
