Réponse de l'administration

La procédure suivie pour l'établissement de la liste des fonctionnaires auxquels sont appliquées les mesures de dégagement peut paraître complexe. Elle passe par l'établissement de critères qui ne peuvent évidemment être définis qu'après réception des candidatures. La phase suivante est la consultation de la commission paritaire, après laquelle la décision définitive est prise par la Commission. Ce n'est que lorsque cette décision est prise que des informations valables peuvent être données aux candidats. Ceux-ci ont toujours bénéficié d'un délai raisonnable pour préparer leur départ sauf lorsqu'à la fin de l'année, il a fallu exploiter les dernières

possibilités offertes par des désistements imprévus.

Le calendrier prévu pour l'exercice 1987 vise à obtenir l'avis de la commission paritaire lors de sa séance du mois de mars de façon à faire prendre la décision définitive sur la liste des dégagés dans le courant du mois d'avril. Le nombre des "volontaires" est de 241 (207 pour le budget de fonctionnement et 34 pour le budget de recherche). La prolongation du délai de réponse n'a pas, comme le croit le lecteur, permis de doubler le nombre des candidats. Elle a seulement permis d'enregistrer 25 candidatures nouvelles.



Un pionnier nous quitte !

M. Jacobus Nicolaas Stempels, un des piliers du secrétariat général, qui a atteint l'âge de la retraite, a quitté la Commission le 1er décembre 1986.

Né à Utrecht en novembre 1921, M. Jacobus Nicolaas Stempels, tout en poursuivant des études de droit, s'engage très tôt dans l'action politique que suscite la montée des périls en Europe. C'est pour lui la prise en charge des réfugiés, pour la plupart juifs, fuyant le régime nazi, puis une part active dans la résistance néerlandaise.

Après la guerre, diplômé en droit à l'université d'Utrecht, il passe par l'industrie, puis entre en 1951 au secrétariat du patronat néerlandais. C'est l'époque où l'Europe se relève péniblement des traumatismes et des

horreurs de la guerre et où les meilleurs esprits cherchent comment en bannir à jamais le retour. M. Jacobus Nicolaas Stempels qui a souffert personnellement de la guerre s'intéresse de près aux idées d'intégration européenne qui commencent à prendre figure, aussi, c'est tout naturellement qu'il accepte en septembre 1958 de venir travailler au secrétariat exécutif de la CEE lorsque M. van Kainebeek, directeur général de l'administration le lui propose.

Comme l'a souligné, dans un hommage plein d'humour et de chaleur, Lino Facco entouré de tous les assistants lors d'un déjeuner offert en son honneur, à l'issue de la millième réunion des assistants, c'est "l'heure des formidables hollandais, symboli-
