Explanatory Memorandum

1. Article 22 of the Act concerning the conditions of accession of the Hellenic Republic and the adjustments to the Treaties provides that "the adaptations to the acts listed in Annex II to this Act made necessary by the accession be drawn up in conformity with the guidelines set out in that Annex and in accordance with the procedure and under the conditions laid down in Article 146."

Council Decision 77/795/EEC of 12 December 1977 establishing a common procedure for the exchange of information on the quality of surface fresh water in the Community (1) is listed under point 1 of Paragraph VIII of Annex II to the abovementioned Act.

2. The list of sampling or measuring stations located in Greece involved in the exchange of information as communicated by Greece should be inserted between France and Ireland in Annex I to the abovementioned Decision. The Commission is satisfied that these stations meet the requirements laid down in Article 5(2) of the Directive.
3. The purpose of this Commission proposal is to amend Decision 77/795/EEC. It is presented under Article 146 of the Act of Accession for Greece.
4. The Council is requested to adopt the attached Decision.
