**COUNCIL REGULATION (EEC) ON THE IMPLEMENTATION IN THE COMMUNITY OF THE CONVENTION  
ON INTERNATIONAL TRADE IN ENDANGERED SPECIES OF WILD FAUNA AND FLORA**

(Commission proposal submitted to the Council on 29 July 1980)

At the session of the European Parliament of 16 October 1980, the Commission accepted a certain number of modifications to the proposal for a Council Regulation (EEC) on common rules covering imports of whale products. These modifications also apply to the proposal for a Council Regulation (EEC) on the implementation in the Community of the Convention on International Trade in Endangered Species of Wild Fauna and Flora.

According to Article 149(2) of the Treaty, the Commission proposes to the Council the following modifications :
