The situation in the potato sector continues to be difficult.

In spite of professional opinion that production is higher than forecast, considerable price rises have occurred on certain markets like those of Rotterdam and Arras. Quoted prices are higher than the already high prices at the beginning of 1976.

Stocks continue to be insufficient and are of poor quality, especially in herms of calibration. As a result, the processing industry is obliged to import from abroad.

In order to ease the future supply of the Community market and at the same time to restrain the forecast trend towards higher prices,

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 28 thereof,

Having regard to the draft Regulation submitted by the Commission,

Whereas, in view of the risk of increases in the cost of living as a result of the present inadequate supplies of potatoes in the Community, the suspension of the autonomous Common Customs Tariff duties currently applying pursuant to Regulation (EEC) No 2894/76<sup>1</sup> and expiring on 28 February 1977, should be extended from 1 March until 31 March 1977 for potatoes falling within subheading 07.01 A II a) and from 1 March until 15 April 1977 for potatoes falling within subheading 07.01 A III b),

HAS ADOPTED THIS REGULATION :

## Article 1

The autonomous Common Customs Tariff duties on the following goods shall be totally suspended for the period indicated in respect of each of them :

CCT heading No	Description of goods	Period
07.01 A II a)	New potatoes	from 1 March until 31 March 1977
07.01 A III b)	Other potatoes	from 1 March until 15 April 1977

## Article 2

This Regulation shall enter into force on 1 March 1977.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
