EXPLANATORY MEMORANDUM

Pursuant to Regulation (EEC) No 1411/71<sup>(1)</sup> as amended by Regulation (EEC) No 566/76<sup>(2)</sup> the Member States have, as from 1 October 1976, applied to whole milk for human consumption either the formula of non-standardized whole milk whose fat content has not been altered since the milking stage (Ireland and the United Kingdom) or the formula of standardized whole milk with a minimum fat content of 3.5% (all other Member States, with the exception of Italy who have made use of the authorization laid down in Article 6(3) of the aforesaid Regulation.

Pursuant to Article 3 of Regulation (EEC) No 1411/71, Ireland and the United Kingdom must, however, permit the marketing on their territories of standardised whole milk coming from another Member State if the fat content of such milk is not less than a percentage to be fixed for each milk year and corresponds to the weighted average fat content of the whole milk produced and marketed in the Member State in question during the previous year (guideline figure).

According to the figures supplied to the Commission by the two Member States concerned, the above-mentioned weighted average is 3,52% for Ireland and 3,83% for the United Kingdom.

It is therefore proposed that the Council should, pursuant to Article 3(7) of Regulation (EEC) No 1411/71, fix those figures as guideline figures for the milk year 1983/1984.

THE COUNCIL OF THE EUROPEAN  
COMMUNITIES,

Having regard to the Treaty establishing the European  
Economic Community,

Having regard to Council Regulation (EEC) No  
1411/71 of 29 June 1971 laying down additional rules  
on the common organization of the market in milk  
and milk products falling within tariff heading No  
04.01<sup>(1)</sup>, as last amended by Regulation (EEC) No  
566/76<sup>(2)</sup>, and in particular Article 3 (6) (b) thereof,

Having regard to the proposal from the Commission,

Whereas, pursuant to Article 3 (5) of Regulation (EEC)  
No 1411/71, Ireland and the United Kingdom apply  
within their territories the formula of non-standard-  
ized whole milk within the meaning of the second  
indent of Article 3 (i)(b) of that Regulation;

Whereas, pursuant to Article 3 (6) and (7), a guideline  
figure must be fixed for the 1983/84 milk year for the  
fat which standardized whole milk coming from

another Member State must contain to be able to be  
marketed within the territories of the two abovementioned  
Member States; whereas this guideline figure  
must be the weighted average fat content of the whole  
milk produced and marketed in the importing  
Member State during the previous year,

HAS ADOPTED THIS REGULATION:

*Article 1*

For the 1983/84 milk year, the guideline figure  
referred to in Article 3 (6) (b) of Regulation (EEC) No  
1411/71 shall be:

- 3.52% for Ireland,
- 3.83% for the United Kingdom.

*Article 2*

This Regulation shall enter into force on the third day  
following its publication in the *Official Journal of  
the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member  
States.
