COUNCIL REGULATION (EEC)

**extending the 1979/80 milk year and amending Regulations (EEC) No 1961/75
and (EEC) No 3066/75**

THE COUNCIL OF THE EUROPEAN
COMMUNITIES,

Having regard to the Treaty establishing the European
Economic Community,

Having regard to Council Regulation (EEC) No
804/68 of 27 June 1968 on the common organization
of the market in milk and milk products⁽¹⁾, as last
amended by Regulation (EEC) No 1761/78⁽²⁾, and in
particular Article 2 and Article 18 (1) thereof,

Having regard to the proposal from the Commission,

Whereas it has not been possible to fix in due time
the prices for the 1980/81 milk year; whereas it is
accordingly necessary to extend the 1979/80 milk
year;

Whereas the application of Council Regulation (EEC)
No 1961/75 of 28 July 1975 on the prohibition of the
use of inward processing arrangements in respect of
skimmed-milk powder⁽³⁾ and Council Regulation
(EEC) No 3066/75 of 24 November 1975 on the prohi-
bition of the use of inward processing arrangements
in respect of butter⁽⁴⁾, both as last amended
by Regulation (EEC) No 875/77 (5), was
limited to 31 March 1980,

This Regulation shall be binding in its entirety and directly applicable in all Member
States.

Done at Brussels,

For the Council

the date on which the 1979/80 milk year should have
ended; whereas, pending a decision on the Commis-
sion proposal in this matter, the application of these
Regulations should be extended until the end of the
present milk year,

HAS ADOPTED THIS REGULATION:

Article 1

The 1979/80 milk year shall end on 30.4. 1980
and the 1980/81 milk year shall commence on 1.5.
1980.

Article 2

In Article 3 (2) of Regulation (EEC) No 1961/75 and
in Article 1 of Regulation (EEC) No 3066/75 '31
March 1980' shall be replaced by '30.4. 1980'.

Article 3

This Regulation shall enter into force on 1 April
1980.

COUNCIL REGULATION (EEC)

extending the ~~1979/1980~~ marketing year for beef and veal

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organization of the market in beef and veal⁽¹⁾, as last amended by Regulation (EEC) No ~~2914/79~~⁽²⁾, and in particular Article 4 thereof,

Having regard to the proposal from the Commission,

Whereas it has become necessary to reconsider all the matters bearing on the fixing of prices for the coming year, which will involve delay in the fixing of these

prices; whereas it is accordingly necessary to extend the ~~1979/80~~ marketing year for beef and veal until

4 May 1980;

HAS ADOPTED THIS REGULATION:

Article 1

The ~~1979/80~~ marketing year for beef and veal shall end on 4 May 1980 and the ~~1980/81~~ marketing year shall commence on 5 May 1980.

Article 2

This Regulation shall enter into force on 7 April 1980.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
