EXPLANATORY MEMORANDUM

On the basis of Protocol No 1 annexed to the Agreement between the Community and Yugoslavia the Council has adopted Regulation (EEC) No 3810/81 establishing ceilings and Community surveillance for imports of certain products originating in Yugoslavia (1982).

From the entry into force of Regulation (EEC) No .../82 of the Council establishing the arrangements applicable to imports of products originating in Yugoslavia consequent on the accession of the Hellenic Republic to the Community (1), Greece is required to apply these tariff measures. An amendment to the abovementioned regulation is therefore required.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas by Council Regulation (EEC) No 3810/81 (1) the Community established ceilings and Community surveillance for imports of certain products originating in Yugoslavia; whereas Council Regulation (EEC) No .../82 of 1982 establishing the arrangements applicable to imports of products originating in Yugoslavia consequent on the accession of the Hellenic Republic to the Community (2) provides for an increase in the amounts of ceilings established by the abovementioned Regulation; whereas Regulation (EEC) No 3810/81 should therefore be amended,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 3810/81 is hereby amended as follows:

- 1. Subparagraph 2 of Article 1 (3) shall be replaced by the following text:
 - "In the case of such reintroduction, Greece shall reintroduce the levying of customs duties calculated in accordance with the relevant provisions in the Act of Accession of 1979 and in Regulation (EEC) No .../82".
- 2. With the exception of Order Nos. I YU 30 to I YU 86 in Annex I, which remain unchanged, Annexes I, II, III and IV shall be replaced by the following:
