MOTIVATION

This Regulation takes into account the practical difficulties which have occurred in connection with the transfer of beef meat held by the intervention agencies of the Member States into Italy. Since the transfer cannot be finished before 1 April 1977 as provided for by Article 1 of Council Regulation (EEC) No 2453/76 of 5 October 1976 on the transfer to the Italian intervention agency of frozen beef and veal held by the intervention agencies of other Member States, this final date must be replaced by that of 1 July 1977.

COUNCIL REGULATION (EEC)

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organization of the market in beef and veal⁽¹⁾, as last amended by Regulation (EEC) No 568/76⁽²⁾, and in particular Article 7 (2) thereof,

Having regard to Council Regulation (EEC) No 729/70 of 21 April 1970 on the financing of the common agricultural policy⁽³⁾, as last amended by Regulation (EEC) No 2788/72⁽⁴⁾, and in particular Article 3 (2) thereof,

Having regard to the proposal from the Commission,

Whereas Article 1 of Council Regulation (EEC) No 2453/76 of 5 October 1976 on the transfer to the Italian intervention agency of frozen beef held by the intervention agencies of other Member States⁽⁵⁾, provides for the disposal of certain quantities of carcasses, compensated quarters and boned beef on the Italian market before 1 April 1977;

Whereas this date should be changed to 1 July 1977, as the transfer of this meat is taking longer than expected;

HAS ADOPTED THIS REGULATION :

Article 1

In Article 1 (1) of Regulation (EEC) No 2453/76, the date "1 April 1977" is replaced by "1 July 1977".
