EXPLANATORY MEMORANDUM

The Regulations (EEC) Nos 87/76, 88/76, 90/76 and 92/76 (1) establish indicative ceilings and Community supervision for imports of certain products originating in Austria, Finland, Norway and Sweden for the year 1976. The products concerned by these measures are specified in the annexes to these Regulations by indication of their Nimexe-code of the "Nomenclature of goods for the External Trade Statistics of the Community and Statistics of Trade between Member States (Nimexe)".

A new modified code of the "Nimexe" entered into force by Regulation (EEC) No 3218/75 (2). These modifications concern some goods falling under the dispositions of the Regulations (EEC) Nos 87/76, 88/76, 90/76 and 92/76. Consequently these Regulations have to be modified too.

This is the subject of the annexed proposal of a Regulation.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,
and in particular Article 113 thereof,

Having regard to the proposal of the Commission,

Whereas Regulations (EEC) Nos 87/76, 88/76, 90/76 and 92/76 (1)
establish indicative ceilings and Community supervision for imports
of certain products originating respectively in Austria,
Finland, Norway and Sweden; whereas the products concerned by those
measures are specified therein by an indication of the Nimexe-code of the
Nomenclature of Goods for the External Trade Statistics of the Commu-
nity and Statistics of Trade between Member States (Nimexe); whereas
the codification of this nomenclature has been amended by Regulation (EEC)
No 3218/75 (2); whereas the Nimexe-code of the products concerned in the
above Regulations should be amended accordingly ;

HAS ADOPTED THIS REGULATION :

Article 1

1. In column 4 of Annex I to Regulation (EEC) N° 87/76, the

amended to read as follows :

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

It is applicable with effect from 1st January 1976.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
