# The 1997 Cohesion Fund Report

On 13 October, the Commission adopted its report on the work of the Cohesion Fund in 1997. During the first five years, ECU 10.76 billion, almost two thirds of the total funding available, has been committed in the four beneficiary Member States. The breakdown among them lies at the mid-point of the ranges laid down in the Regulation: Spain 55%; Portugal 18%; Greece 18% and Ireland 9%.

Most of the assistance provided by the Fund in 1997 was for managing and checking a large number of projects approved in earlier years, which absorb the bulk of the financial resources. The increase in the proportion of the budget going to environmental projects (see Inforegio News No. 49) means that a 50/50 balance with transport projects (which originally absorbed a larger part of the appropriations) has almost been achieved. Another feature is the increased funding for rail transport.

**Spain.** New environmental projects include facilities to improve the quality of water in the Ebro at Logroño and in the Arga at Pamplona and the laying-out of a park along the Móstoles near Madrid. In the transport sector, projects which the Commission decided to support include completion of the Rías Bajas motorway in Galicia, the Madrid-Valencia road and construction of the first two sections of the high-speed rail line from Madrid to Barcelona.

**Portugal.** Fifteen new environmental projects were approved, covering the protection of coastal areas, the disposal of solid waste and waste-water drainage and treatment. Port infrastructure is currently being part-financed at Sines, Lisbon, Setúbal and Leixões, as are a new section of the Lisbon-Madrid motorway,

the Pampilhosa-Quintans rail link and the modernisation of Funchal airport on Madeira.

**Greece:** During 1997, 27 environmental projects were approved, including improved systems for waste treatment and water supply in Athens and waste-disposal projects in Thessaloniki and Katerini. Assistance to transport infrastructure went mainly to the Via Egnatia, which crosses Greece from the port of Igoumenitsa to the Turkish border, the Pathe motorway (Patras-Athens-Thessaloniki-Evzoni), Thriassio station and the Thriassio-Elefsis-Corinth railway line.

**Ireland.** Support was provided for projects to treat water drawn from lakes and rivers and for improvements to the distribution systems in Dublin, Waterford, Cork, Limerick and Wexford. In the transport sector, support was provided for the Dublin ringroad, for several major roads radiating from the capital (to Belfast, Cork and Limerick) and for a number of railway lines, some of which (Dublin-Belfast and Dublin-Cork) have already been completed.

## Conference on the territorial pacts for employment

How is it possible, given the variety of economic, social, cultural, legislative and institutional backgrounds, to adapt "good practice" on the creation of economic activity and jobs for use elsewhere?

That was the main question considered at Turku (Finland) on 8, 9 and 10 October, during the first exchange of views on local development and employment organised by the European Commission.

On this occasion, the coordinators of the territorial pacts, whose strategy currently covers 1998-99, identified a number of these "good practices" in all the Member States which could be used as models.

The conference, which followed the pattern of the Directoria seminars on inter-regional cooperation, covered 82 of the 89 pacts and was attended by 28 managers of model projects. Over 700 bilateral meetings were scheduled.

The success of the formula is demonstrated by the large number of unscheduled meetings which were organised on-the-spot. Exchanges took place broadly at two levels: some pact coordinators wanted simply to adjust their strategy, mainly as regards promoting the territorial partnership, while others sought the transfer of operational instruments, which could be used immediately (mainly in the areas of the establishment of firms, platforms for services, venture capital and the information society).

The Commission announced that it was considering whether extra finance could be provided to develop this type of transfer of good practice and to provide links with the next programming period of the Structural Funds.
