A memorandum to strengthen the competitiveness of SMEs in the European Community

On 30 September 1993, the Belgian Presidency of the Council of the European Communities made public the main lines of a memorandum about strengthening the competitiveness of the Small and Medium-sized Enterprises (SMEs) of the Community in the Internal Market. This memorandum, accompanied by 38 practical recommendations, will be submitted on 11 November 1993 to the 'Internal Market' Council, which will be devoting part of its session to the Community's SMEs, for the first time. The purpose of the memorandum is to enable SMEs, which are the main source of increasing employment, to increase their competitiveness, deal with structural change, and derive maximum benefit from the internal market.

With a view to this discussion, which could lead to a Council Resolution being taken, the document suggests that the Council and the Commission should set up an integrated strategy which will improve the synergy between the Community policy in favour of SMEs, and national and regional policies. In the same context, the memorandum proposes that the Community should introduce more systematic consultation prior to action between the European Commission and the organisations representing SMEs, at all stages of the decision-making process, and involve these organisations directly in the social dialogue foreseen in the Maastricht Treaty.

The memorandum also suggests setting up further accompanying measures to solve structural problems facing SMEs: reducing administrative formalities, increasing access to capital markets for SMEs, and meeting their increasing need for information about the opportunities of the internal market, in particular with regard to subcontracting, research, public procurement and support for local and regional development of SMEs. In addition to a strategy aimed at improving the chances for survival and development of SMEs, the memorandum recommends that the Council and the Commission should increase the capacity of SMEs to finance their own development, through fiscal measures at Member State level, and set up at Community level a ceiling on the rate of taxation for profits retained and reinvested in the business.

In order to preserve the wealth of diversity in the world of SMEs, certain 'customised' measures are also planned. For subcontractors, the memorandum emphasises the importance of effective spreading of the opportunities on the Community subcontracting market. It also recommends setting up codes of practice for main contractors, and informing subcontractors of the regulatory provisions applicable in the various Member States, in particular in terms of time taken to pay bills.

Craft businesses and micro-businesses are also among the major concerns of the Belgian Presidency. It supports the action of the Commission in preparing the second European Crafts Conference (Berlin, 1994). Finally, in the context of the Fourth Framework Programme of Research and Technological Development, the Belgian Presidency is stressing the importance to be accorded to technology SMEs (better access to Community research programmes).

Far from questioning the achievements of the work carried out at Community level since 1986, the Belgian Presidency is confirming the main lines of Community policy in favour of SMEs, and requesting that certain activities which are regarded as priorities should be extended, via concerted action between the Community and the Member States. The Commission is pleased that, in parallel with the implementation of the Council decision of 14 June 1993 ²)which sets out a clear and coherent framework for the work over the next three years, this memorandum from the Belgian Presidency will enable a process of reflection to take place about ways of extending this policy, to deal with the challenges facing SMEs every day.

When facing technological change, SMEs are confronted with specific problems, and have to seek ways of improving their competitiveness, in particular through cooperation and technology transfer. For several years, the Community has been endeavouring to respond to these needs through measures aimed at facilitating the involvement of SMEs in its research and technological development (RTD).

Various actions, covering the various stages of the innovation process have been set up to help SMEs:

TO INVOLVE THEM IN RTD PROGRAMMES

- BRITE-EURAM FEASIBILITY GRANTS: financial contribution to the costs connected with the preparation of projects. Subsidies can be as high as 75% of the costs (maximum 30 000 ECUs) for research work to establish the feasibility of new equipment, processes or concepts.

A communication adopted by the Commission at the end of September³ reviews the progress achieved, and examines how involvement of SMEs in Community programmes could be increased.

The 4th Framework Programme of Community RTD for 1994-1998 should constitute significant progress for SMEs, particularly with the extension to other programmes of the CRAFT system of cooperative research, the feasibility grants currently paid under BRITE-EURAM (industrial and materials technologies), and with larger VALUE and SPRINT programmes for valorisation of Community research and technology transfer to SMEs.

Moreover, the Commission will consolidate its actions and information networks on Community research and its exploitation (VALUE relay centres, Euro Info Centres). Finally, to take account of the difficulties encountered so far by SMEs, the Commission has implemented measures to simplify the tendering and project management procedures.

TOWARDS A MORE FAVOURABLE FINANCIAL ENVIRONMENT FOR SMES

On the initiative of Mr. Raniero VANNI D'ARCHIRAFI, member of the European Commission responsible for Enterprise Policy, and particularly SMEs, VIPs from the banking industry of the European Community met in Brussels, for a Round Table discussion about improving the financial environment for Small and Medium-sized Enterprises.

The purpose of the Round Table, which will meet at regular intervals — will be to undertake a process of detailed reflection on the financing difficulties specific to SMEs, and ways of solving these problems. The analysis will not be restricted to access for SMEs to bank credit, but will also deal with access to venture capital. Henceforth, it will be a matter of identifying practical measures within the Community, evaluating the possibilities of transposing measures to other Member States and suggesting new approaches encouraging a better financial environment for SMEs. It will also involve examining the role which the European Commission could play in promoting those financial instruments which are most favourable for SMEs, devising new financial instruments, or for improving the financial structure of SMEs.

CRAFTS: Preparatory colloquia for the 2nd European Crafts Conference

On 14 June 1993⁴, the Council of Ministers adopted a Community action programme for the period 1993-1996, to intensify a number of priority areas of Community enterprise policy, in particular SMEs, and to ensure the continuity of this policy in a number of fields. The Commission will continue and consolidate its action in favour of crafts and very small enterprises, to help them to derive maximum benefit from the opportunities offered by the completion of the internal market. In order to determine the most effective actions to be carried out in their favour, the Commission has decided to organise in September 1994, in Berlin, a second European Crafts and Small Business Conference. This Conference will be preceded by a series of preparatory colloquia ⁵, and the following have been added to the list:

SUBCONTRACTING: European statistics soon

Subcontracting is a key factor in the competitiveness of European companies. This competitiveness depends on the capacity of subcontracting firms to innovate, and respond, in terms of quality, delivery times and costs, and the increasing demands of a constantly changing world market.

In this context, the Commission has launched actions along three main lines:

- creation of a favourable environment for the development of subcontracting;
- improvement of information and communication between main contractors and subcontractors;
- valorisation and promotion of European subcontracting with investors from third countries.

A pan-European Subcontracting conference was held in Madrid, on 14 and 15 December 1992. It brought together all the actors in the subcontracting relationship, and reviewed the situation and prospects for change in this sector, based on economic and legal studies, and networking of subcontracting exchanges ⁶.

DG XXIII, in cooperation with EUROSTAT (Statistical Office of the European Communities) recently launched a statistical survey which will enable accurate evaluation of the scale of the phenomenon of subcontracting in Europe. It will affect various industrial sectors, including: electronics, vehicle manufacture, aerospace, textiles/clothing. To carry out this exercise, EUROSTAT is coordinating the activities of national statistical offices in Europe on these themes. The latter will be working in close cooperation with the various professional associations concerned. The first results will be available in early 1994.

BC-NET: Canada and Morocco join

During the annual cooperation conference, on 1 and 2 July in Brussels, the memorandum to join the BC-NET (Business Cooperation Network) was signed by Canada and Morocco. BC-NET is a network of around 600 business advisers and intermediaries throughout the European Community, EFTA countries, and a growing number of third countries. This network enables businesses to identify quickly and confidentially potential partners in other Member States and other regions, in response to a specific proposal for cooperation. The business advisers in the BC-NET network analyse the cooperation opportunities proposed by firms, pass them on to a central organisation (the BC-NET Central System — BCS) which is responsible for matching them, deal with responses from the central system, and possibly, take part in the negotiations leading to conclusion of cooperation agreements between the firms.

Since it was launched in 1988, BC-NET has dealt with over 70 000 requests for cooperation (financial, technical or commercial) from all types of business and manufacturing and service industries.
