INTEREST

A Conference on WOMEN IN THE INFORMATION SOCIETY is being organised by the 'Berätungs- und Informationsstelle Förschungsförderung (BIF)' of the Ruhr-Universität Bochum. It will be held on 17 March 1997 in the Mediapark in Köln. Mrs Erika MANN, MEP, Member of the Committee on External Economic Relations, will be a key speaker. It is planned that the Bochum team will be invited to STOA's forthcoming Workshop on 'Women and the Net'.

- On Monday, 16 December 1996, under the auspices of the Parliamentary Assembly of the Council of Europe, a Conference on TECHNOLOGICAL ASSESSMENT, RESEARCH EVALUATION AND FORESIGHT STUDIES will take place in Strasbourg. There will be presentations by 8 leading research organisations in this field from around Europe. Representatives of the European Parliament, the European Commission, and national parliaments from Member States of the European Council will take part.
- The European Commission (the Institute for Prospective Technological Studies, DGXII.B and the Forward Studies Unit) is organising a Symposium on INTERNATIONAL COOPERATION IN RESEARCH AND TECHNOLOGICAL DEVELOPMENT at the Hotel Eurovillage in Brussels on Tuesday, 19 November. Mrs CRESSON, Commissioner responsible for research, education and training, had welcomed this proposal at the time when the European Parliament (rapporteur Prof. POMPIDOU) had suggested it in its report on the Commission's communication on perspectives for international cooperation in research and technological development (RTD).

The main objective of the Symposium is to define the strategic orientations for international RTD cooperation at EU level. This will form an input to the EC reflections for the elaboration of the relevant chapter in the 5th Framework Programme for RTD (1998-2002).

Prof. ROUTTI, Director-General for Research in the European Commission (DG XII) and Prof. POMPIDOU, MEP, will open the Symposium. Prof. VALLS PASOLA, STOA contractor for the 1996 project on 'Technological innovation and money' is rapporteur for the workshop on Mediterranean and developing countries.
