MOTION FOR A RESOLUTION

tabled by Miss HOOPER, Mrs BOOT, Mrs PHLIX, Mr ROGALLA, Mr BALFE, Mr ROGERS

pursuant to Rule 47 of the Rules of Procedure

on the organisation of a European Music Year

The European Parliament,

- A. having regard to the Hahn Report (Doc.1-345/80) and the decision of the European Parliament to support the organisation of a European Music Year in 1985,
- B. having regard to the stated aim of the European Community to further cultural cooperation on as broad a basis as possible with particular reference to daily life in the Member States,
- C. having regard to the nature of music as a medium which overcomes all language barriers,
- 1. Requests that the majority of funds available for musical projects under the Social Fund and for special projects during European Music Year be directed towards musical projects which will reach the largest number of European citizens;
- 2. Requests that one of the stated aims of European Music Year should be to encourage participation by European citizens who would not normally be involved in musical events;
- 3. Feels, therefore, that projects concerned only with highest standards and prestige of music should not be the sole medium for promoting the idea of European unity in music and would not reach the maximum number of people;
- 4. Asks that special consideration be given to musical projects involving musicians from all member states, for example transfrontier youth concerts;
- 5. Instructs the President to forward this Resolution to the Commission and the Council.

The Committee on Budgetary Control hereby submits to the European Parliament the following proposed decision:

PROPOSED DECISION

on the discharge to be granted to the Commission of the European Communities in respect of the activities of the second and third European Deveopment Funds in the 1981 financial year

The European Parliament,

- having regard to the report of the Court of Auditors on the accounts for the financial year 1981 accompanied by the replies of the institutions 1,
- having regard to the balance sheet and accounts of the European Development Funds for the 1981 financial year (COM(82) 824 final),
- having regard to the report of the Committee on Budgetary Control (Doc. 1-112/83),
- whereas the Treaty of 22 July 1975 empowers Parliament to grant a discharge in respect of budgetary activities,
- Grants the Commission a discharge in respect of the financial management of the second and third European Development Funds in the 1981 financial year;
- 2. Instructs its President to communicate this decision to the Commission of the European Communities, to forward it to the other institutions and to arrange for its publication in the Official Journal (L series).
