**TRENDS IN THE EC AGRICULTURAL PRICE INDICES
(OUTPUT AND INPUT)
IN THE THIRD QUARTER OF 1991**

Producer prices of agricultural products (output)

*Prices down in real terms
(Nominal change: +2.2%, real: -3.6%)*

The average monthly index of **producer prices of agricultural products** (including fruit and vegetables), for the Community as a whole (EUR 11), increased +2.2%, in *nominal* terms, in the third quarter of 1991 relative to the third quarter of 1990 (see Table 1). *Real* prices were down -3.6% on the corresponding quarter of 1990, this real price fall was the smallest since the second quarter of 1990.

As has been the case in the preceding quarters of 1991, *real* producer prices for *crop products* stayed level (-0.1%) in comparison with the corresponding quarter of 1990. Although the index for crop products remained stable, there were large changes in the real prices for some of its components. For the Community (EUR 11), real cereal prices were down (-2.3%), a sharp reversal from the rise (+4.7%) for the second quarter of 1991. The causes of this reversal are to be found in large differences in the rates of change of cereal prices, vis-à-vis the second quarter, in the four Member States which have the highest weightings (F,I,UK and E). Real prices for vegetables dropped -5.1%. Conversely, the root crops index went up +8.8% in real terms after a series of large quarterly falls, the most recent being -5.4% for the second quarter of 1991. This was due to large fluctuations in potato prices. Real prices for olives and olive oil remained extremely buoyant (+19.5%), and real fruit prices rose +6.8%. Real prices for seeds continued to fall (-5.9%), as did those for wine must and wine (-6.4%).

The above changes masked considerable divergences for the various product groups in individual member states. Real cereal prices in France and Spain remained roughly constant (+0.1% F and -0.6% E), while in the United Kingdom and Italy prices were lower (-3.2% UK and -2.9% I). The deflated root crops index showed remarkable variation across Member states from an increase in Ireland of +42.8%, to a fall in Denmark of -11.8%. In the United Kingdom and Spain real prices of root crops were substantially higher (+16.9% UK and +20.0% E). The overall rise (EUR 11) in the real price of fruit was not as large as last

quarter (+6.8% in the third quarter compared with +9.1 in the second), but fruit prices rose by +38.5% in France and +33% in Germany while they fell -15.2% in the United Kingdom. Vegetable prices, in real terms, rose +10.7% in Spain and +5.9% in Denmark, but they fell elsewhere, particularly in Belgium (-21.0%) and Greece (-25.1%), but also in Germany (-11.8%) and the United Kingdom (-14.3%). Real wine prices rose in Germany and Greece (D +7.3% and GR +8.9%) whilst falling in other wine-producing countries, though in Spain the drop was much less than in the second quarter (-15.7% cf. -23.7%). Real olive and olive oil prices rose much more sharply in Italy (+31.1%) and Greece (+26.2%) than in Spain (+5.6%). The real price of seeds rose only in Belgium (+11.3%) falling sharply in the United Kingdom (-11.4%) and Greece (-14.1%). Flower prices in Belgium rose very sharply (+39.3%) less so in Greece (+17.5%), and continued to drop steeply in Spain (-22.0%).

Deflated prices for the animal sector fell (-6.8%). Real prices of calves, cattle and pigs all fell less sharply than in the second quarter (see Table 1), though cattle prices still fell the most (-9.9%). Two countries saw shallower declines in cattle prices this quarter (UK -3.0% and IRL -7.4%). Real pig prices have decreased (-5.8% for the EUR 11), but only -0.8% in the Netherlands and -1.3% in Germany, while prices plummeted in the United Kingdom (-23.7%) and Ireland (-14.0%). Changes in milk prices were similar to those of the second quarter with a fall (-6.0%) for the community as a whole (EUR 11).

At Member State level changes in *nominal* producer prices for agricultural products range from -9.8% (L) to +12.1% (GR). In *deflated* form the range is between -12.9% (L) and -2.2% (E). This real output price fall for Spain (-2.2%) in the third quarter compared with -10.5% and -10.9% for the first and second quarter, respectively. In Greece, real output prices have deteriorated (-4.9%), compared with increases of +1.1% and +2.7% in the first and second quarter, respectively. In both these countries the large shifts occurred due to changes in crop rather than animal prices.

Purchase prices of goods and services for current consumption (Input I)

Up by +3.7% in nominal terms, but down only -1.8% in real terms

The rise in the *nominal index* for purchase prices of goods and services for current consumption (+3.7%) was the latest of a series of steadily larger increases, quarter by quarter, and the corresponding drop in *real* prices (-1.8%) was smaller than in earlier quarters. The real feedingstuffs index, which declined -3.0% this quarter and is heavily weighted within the Input I index, follows an accentuated trend of lessening real price falls (see Table 3). Real prices of fertilizers were down -3.3%, and those for animals for rearing have fallen -2.6%. Real prices of energy were virtually constant (-0.4%) after real price rises earlier in the year. Real prices of seeds fell(-4.8%), while price changes for the remaining components of the Input I index lay between +1.1% (Plant protection products and Maintenance and repair of plant) and -1.3% (Veterinary services).

Comparison of the *nominal* price changes relative to the third quarter of 1990 for inputs between Member States (cf. Table 4) reveals a range from -0.5%(DK) to +22.7%(GR). The *real* input prices range from -5.0(I) to +4.2%(GR).

Purchase prices of goods and services contributing to agricultural investment (Input II)

Almost constant in real terms (-0.3%)

At the Community level (EUR 11) the price index for goods and services contributing to agricultural investment has altered by +5.5% in *nominal* terms, only -0.3% in *real* terms, from the third quarter of 1990. For nine of the eleven countries the price changes in this index were between +1% and -1%. The exceptions were Spain (-5.3%) and the Netherlands (+1.2%).

Comparison of trends in real output and input (I) prices

Negative net price effect in all Member states (-2.8 points for EUR 11)

In the third quarter of 1991, in the Community as a whole (EUR 11), the deflated output price index fell by -3.6% whilst the deflated input price index fell by -1.8%. Interpretation of these trends should take into account the fact that purchases of goods and services for current consumption in agriculture account for only a part of the value of output (for EUR 11, about 45% in value terms of the total sales of agricultural products, calculated according to the national farm concept). This means that when a decrease in real producer prices is accompanied by a fall in real input prices (as occurred in all Member States except Germany and Greece in the third quarter of 1991) the change in value added due to the output price decrease is partly offset by the decrease in real prices of intermediate consumption. In the case of Greece increased input prices exacerbated the effect of lower output prices. Column 5 of the following table shows the change in value added for each Member State due to price changes alone, expressed as a percentage of total output. The Member States are arranged in order of increasing size of this effect.

The negative net price effect for Luxembourg (-12.1%) was nearly 6 points worse than that for any other Member State. Spain has shown a remarkable change in net price effect from the first and second quarters of 1991 (-0.7% compared with -8.6% and -9.6%). From having second most negative net price effect last quarter, Spain has changed to having the least negative net price effect this quarter. This was due to output prices which fell much less steeply in the third quarter than in the second. For the Community as a whole (EUR 11) the net price effect was -2.8 points.

Technical note

The EC agricultural price indices (output and input) are available in Eurostat's CRONOS data bank ("PRAG" domain) in both nominal and deflated form. By using deflated indices it is possible to eliminate the distortions in the nominal indices caused by different inflation rates in the Member States. The nominal agricultural price indices are deflated by means of consumer price index for each Member State. The terms "deflated" and "real" are used synonymously.

No monthly agricultural price indices are yet available for Portugal.

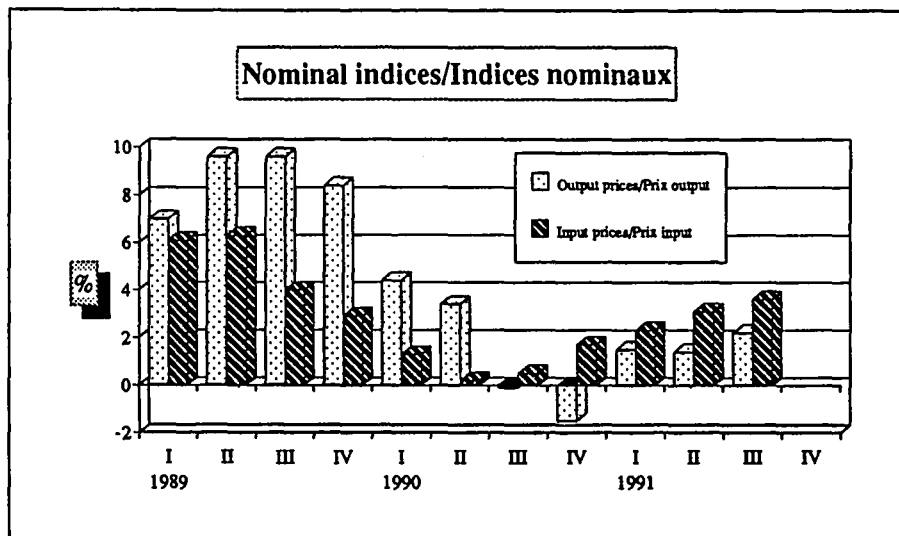

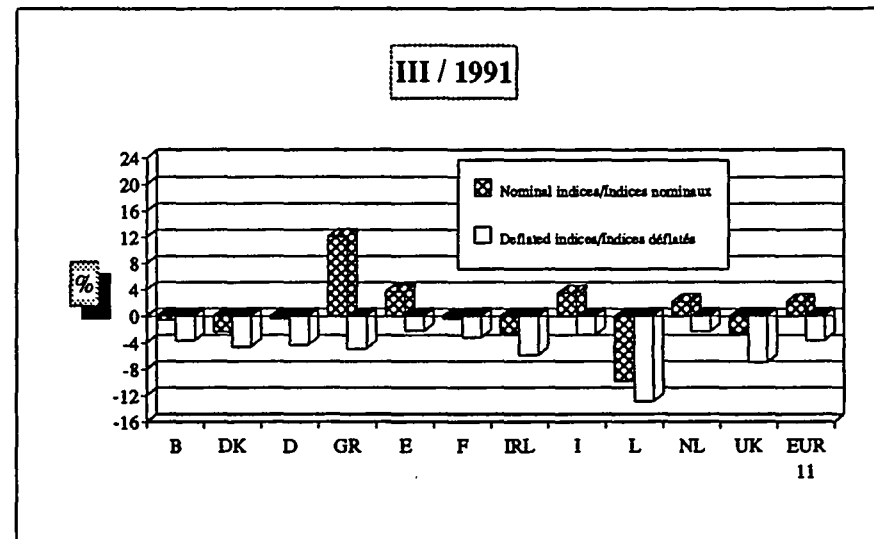
Rates of change over 12 months of the agricultural price indices
