**TRENDS IN THE EC AGRICULTURAL PRICE INDICES  
(OUTPUT AND INPUT)  
IN THE SECOND QUARTER OF 1992**

**Producer prices of agricultural products (output)**

*Strong real price fall  
( -6.3%, 1st Quarter 1992: -1.7%)*

The average monthly index of the producer prices of agricultural products (including fruit and vegetables), for the Community as a whole (EUR 11), decreased -1.2% in *nominal* terms, in the second quarter of 1992 relative to the corresponding quarter of the previous year (see Table 1). This follows five consecutive quarters in which prices increased. The nominal price fall resulted in a stronger real price decline (-6.3%), relative to the second quarter of 1991, which was the greatest decrease since the fourth quarter of 1990.

*Real* producer prices for crop products were, on average, significantly lower (-11.1%) compared with the same period in 1991. There were real price falls for all crop products, and with the exception of fruit (-0.7%), these were all large. Of most significance were the reductions of -11.8% and -15.4% in the real price for cereals and fresh vegetables respectively. Both these products encountered a real price decline for the fourth consecutive quarter. The large decrease for root crops (-18.6%) was attributable more to the slide in real potato prices (-31.8%) compared to the corresponding quarter of the previous year, than to sugar beet (-1.9%).

The deflated price index for animals and animal products was also down (-1.5%), compared to the corresponding quarter of the previous year for the Community (EUR 11), but at a much slower rate than that for crop products. The real price of animals for the Community as a whole remained stable (+0.3%). It was the increase in the real price of pigs (+6.1%) in particular, but also calves (+1.8%) that outweighed the falls in the real prices of all other animals. The increase in real pig prices was a

continuation of the positive rates of change registered in the previous two quarters (+14%) although at only about half the rate, and the increase of the real calves price at the Community level (EUR 11) was due in particular to a +42.4% rise in the United Kingdom. The deflated price index for cattle fell again (-2.3%), for the eleventh consecutive quarter, but at a renewed strength (-1.3% : 1st Quarter 1992). In addition, the deflated price index for sheep and lambs decreased (-1.3%), compared with the same period of last year. The rate of change for the real sheep price of -6.3% in Spain contrasted starkly with that for the United Kingdom (+7.5%).

The real price of milk decreased (-3.4%), in comparison to the same quarter of last year. There were variations in the level of real milk price changes amongst Member States. The real price of eggs was -9.2% down in comparison with the corresponding period last year.

At Member State level, the changes in *nominal* producer price indices for agricultural products as a whole range from -4.4% (F) to +3.4% (IRL) (cf. Table 2). In *deflated* form, the range is between -10.8% (GR) and -0.1 (IRL).

#### **Purchase prices of goods and services for current consumption (Input I)**

*Increase in nominal terms (+2.3%)*  
*Fall in real terms (-2.6%)*

The *nominal* EC price index (EUR 11) for purchase prices of goods and services for current consumption rose by +2.3% in the second quarter of 1992 compared with the same period of the previous year (c.f. Table 3). The corresponding *real* price index fell (-2.6%) at a similar rate to the previous quarter (-2.5%). The real price index decline would be a continuation of the trend for slightly stronger decreases established since the third quarter of 1991, and the twelfth consecutive quarter in which real prices have fallen compared to their corresponding quarters of the previous year.

The real price decline of intermediate consumption was due mainly to real price falls for animal feedingstuffs (-3.4%), fertilizers (-6.7%) and seeds (-6.9%). The real price of most of the goods and services currently consumed in agriculture were lower than the corresponding quarter in 1991; the exceptions were animals for rearing (+3.9%), the maintenance and repair of plant (+1.7%) and general expenses (0.0%).

Comparison of the *nominal* price changes relative to the second quarter of 1991 for input I between Member States (cf. Table 4) reveals a range from -0.9% (L) to +12.0% (GR). The *real* input I price changes range from -5.9% (E) to -0.3% (D).

#### **Purchase prices of goods and services contributing to agricultural investment (Input II)**

*Small increase in real terms (+1.0%)*

At the Community level (EUR 11), the price index for goods and services contributing to agricultural investment has increased by +6.4% in *nominal* terms and by +1.0% in real terms, from the second quarter of 1991. Between Member States real changes in input II prices ranged from -5.6% (GR) to +5.3% (I).

## Comparison of trends in real output and input (I) prices

*Real producer price decreases accompanied by input real price falls  
in most Member States*

*Negative net price effect (-5.1 points)  
for Community agriculture*

In the second quarter of 1992, in the Community as a whole (EUR 11), the deflated output price index fell by -6.3%, whilst the deflated input price index fell by -2.6%. Interpretation of these trends should take into account the fact that purchases of goods and services for current consumption in agriculture account for only a part of the value of output (for EUR 11, about 45% in value terms of the total sales of agricultural products, calculated according to the national farm concept). Therefore, a net price effect is calculated to reflect the impact of real output price and, to a lesser extent, input I price changes on the difference between sales of agricultural products and purchases of intermediate consumption expressed as a proportion of sales. Column 5 of the following table shows this net price effect for each Member State, arranged in the order of increasing size of this effect. Seven Member States demonstrated a negative net price effect, the strongest being in Greece (-10.0 points). For the Community as a whole (EUR 11) the net price effect was -5.1 points.

### Technical note

The EC agricultural price indices (output and input) are available in Eurostat's CRONOS data bank ("PRAG" domain) in both nominal and deflated form. By using deflated indices it is possible to eliminate the distortions in the nominal indices caused by different inflation rates in the Member States. The nominal agricultural price indices are deflated by means of the consumer price index. The terms "deflated" and "real" are used synonymously.

No monthly agricultural price indices are yet available for Portugal.




EC Index of producer prices of agricultural products:

Rates of change of the price indices by Member States


