The European Communities and their Institutions

The European Community consists of six countries — Belgium, France, the Federal Republic of Germany, Italy, Luxembourg and the Netherlands — with a combined population of 170,000,000. These six have bound themselves by the following Treaties, under which their future activities are to become more and more interwoven:

- (1) the Treaty establishing the European Coal and Steel Community, signed in Paris on April 18, 1951;
- (2) the Treaty establishing the European Economic Community, signed in Rome on March 25, 1957;
- (3) the Treaty establishing the European Atomic Energy Community, signed in Rome on March 25, 1957.

The three organizations so established — E.C.S.C., E.E.C. ("the Common Market") and Euratom — are steadily working towards the final blending of the six economies into one. E.C.S.C., the first venture in European integration, introduced the first European Common Market, the Common Market for coal, steel, iron ore and scrap, in 1953; Euratom instituted the Common Market for nuclear products on January 1, 1959; the establishment of the General Common Market, for all goods, services, labour and capital, is under way, and will continue over a transition period originally scheduled to expire at the end of 1969. Progress has already been such, however, as to enable this date to be advanced.

A number of institutions and bodies have been set up to work with one or other of the three Communities. The Economic and Social Committee and the Audit Committee serve both E.E.C. and Euratom.

Co-ordination between the policies of the national Governments and of the European Communities is effected by the Councils of Ministers (the Special Council of Ministers of E.C.S.C., the E.E.C. Council and the Euratom Council). The works of the Executives is closely supervised by the European Parliament, which also plays an active part in the framing of integration policy.

The Court of Justice has sole power to rule as to the maintenance or reversal of the Executives' decisions. It ensures that the implementation of the three Treaties is carried out in accordance with the law.

The member States have permanent delegations to E.E.C. and Euratom, and many non-member countries also have delegations to one or more of the Communities.

INTRODUCTION

I — Contents and arrangements of this Catalogue

This catalogue lists only the titles and relevant particulars of official publications *placed on sale* by the various Institutions and Common Services of the European Communities.

For easier reference, the publications have been catalogued in sections headed by the names of the different Institutions and, within these sections, classified by categories of documents or by major subjects.

Details concerning the *Journal officiel* (Official Gazette) are given in a separate section at the beginning of this catalogue, since it covers the activities of all three Communities.

II — Abbreviations used to denote the languages in which the publications are available

This edition of the catalogue gives an English title only where the publication exists in English; otherwise the French title is quoted, followed by an English translation in brackets.

The abbreviations after each title indicate the languages in which the documents have been published, *viz.* d = German, f = French, i = Italian, n = Dutch, e = English, s = Spanish, e.g. "Journal officiel des Communautés européennes (d-f-i-n)" indicates that there are separate editions available in German, French, Italian and Dutch.

The same abbreviations, but separated by oblique strokes instead of dashes, are used for bilingual and multilingual publications, e.g. "Bulletin général de statistiques (d/f) et (i/n)", indicates that two bilingual editions are available, one in German and French and the other in Italian and Dutch; "Charbons et autres sources d'énergie (d/f/i/n)" indicates a single volume containing the text in all four official languages.

With the exception of the titles for which the names and addresses of specialized selling agents are given in a footnote, all the publications enumerated in this catalogue are obtainable from the official Sales Offices listed overleaf or from all major booksellers.


