Question by Sir Geoffrey DE FREITAS (H-184/75)
 Subject: Tindemans Report

Will the Council ask the Commission and the Parliament to join them in setting up a small ad hoc committee to study the report in conditions which would not in any way commit either the Council, the Commission or Parliament.

2. Question by Mr ZELLER (H-213/75)

Subject: Community membership of the International Agricultural Development Fund

Why have the Community and Member States not yet become members of the International Agricultural Development Fund?

Question by Lord REAY (H-214/75)
 Subject: Surplus stocks of skimmed milk powder.

Now that the Council has refused to increase its allocation of skimmed milk powder in Food Aid for 1976, what steps does the Council intend to take to dispose of the Community's surplus stocks?

4. Question by Mr VERNASCHI (H-215/75)
Subject: Concentration camps for political prisoners in the USSR

Will the Council approach the Government of the USSR to discover the truth or otherwise of the television broadcasts by several European countries, including Italian TV, on the existence of concentration camps and labour camps for political prisoners? Does it intend to propose that a delegation from the UN or the International Red Cross visit Russia to check this information. If it proved true what consequences would this have on relations between the EEC and the USSR?
