Greek MEPs take their seats

"Your country is regarded as the cradle of our civilisation". These words were used in the welcome extended by President Simone Veil to Greece's new 24 Members of the European Parliament when they took their seats in Strasbourg on Monday 12 January. With the accession of Greece, the Community could confidently claim that "it is not a club restricted to the most privileged," added the President.

Pending direct elections in Greece the 24-member Greek delegation is composed as follows:

Mr Bournias of the New Democracy, in reply to Mrs Veil, spoke of his party's enthusiasm for the Community and of his pride in being the first to use the language of Plato in the House. Socialist Ioannis Charalambopoulos stressed that PASOK was against membership not sanctioned by a referendum.

Tuesday 13 January provided several of the Greek Members with an opportunity to make their maiden speeches when the House debated shipping standards and oil pollution. Giorgios Dalakouras of the New Democracy assured the House that with its high level of tourism Greece was anxious to combat coastal pollution. His colleague Giorgios Voyiatzis reminded Parliament that with Greek accession the Community now has the largest fleet in the world.

The new Greek Commissioner Georgios Kontogeorgis has the transport portfolio. In addition to replying to this debate he told the House at Question Time on Monday 12 January that he hoped the Community would have a standard summer time by 1983.

The House has formally agreed to increase the size of its committees to accommodate the appointment of Greek members, which was ratified on Friday 16 January.

1981 and Supplementary 1980 Budgets Adopted

Speaking to Parliament on Monday 12 January President Simone Veil announced that the budgetary procedures for both the general 1981 Community budget and a supplementary budget for 1980 had been completed. In accordance with the Treaties she had declared both budgets adopted. In her statement Madame Veil said "the Council had not been able to pronounce on the amendments which Parliament made to the draft supplementary budget number 2 for 1980 at its sitting of 18 December 1980. The message of the Council President did not include any observation on the draft budget for 1981. Consequently, in accordance with the provisions of the treaties I declared on the same day that the procedure provided for in the Treaties had been completed and that the two budgets were therefore finally adopted".

Replying on behalf of the main political groups of Parliament Ernest Glinne (Soc/Bel) said "we fully approve the decision that you took on behalf of us all". For the European Commission, President Gaston Thorn confirmed, "I would like to make it clear that we consider both the supplementary budget for 1980 and the budget for 1981 to be legal and hence enforceable".

More money for jobs and quake victims

As the Council failed to vote on the amendments to both budgets which had been adopted by Parliament during the December session they therefore remain as part of the final budgets. The amendments comprise, in payment appropriations, some £167.7m (equivalent) of extra expenditure for the Regional and Social Funds including regional employment policy, aid to promote employment, aid for business employment, aid for the disabled, actions to benefit women, action in the agricultural and textile sectors, pilot experiments and studies and aid for vocational training (Supplementary budget for 1980) and an extra £15.4m (equivalent) mainly for funds to alleviate the effects of the Italian earthquake and for developing new energy sources (General budget for 1981).

Action taken on Parliament's Opinions

Each month the Commission reports on the action it has taken in response to the Opinions previously expressed by Parliament.

At its second November part-session the European Parliament voted on the 13 Commission proposals.

4. The Commission informed Parliament of aid it had granted disaster victims since the previous part-session. This included further earthquake aid for Italy, emergency aid for Ugandan refugees and Sudanese drought victims to repair damage caused by torrential rain in the Comoro Island, for Salvadorian refugees in Honduras, and for re-settling refugees in Zimbabwe.

Replies to Members' questions

Cars in Spain — Norvela Forster, Sir Henry Plumb, Robert Moreland, John de Courcy Ling, Richard Cotrrell, Michael Welsh (Dem/UK) WQ 1239/80

Spain operates a quantitative quota for motor imports from the Community. In 1979 this was worth 1,748,935,000 Ptas (approx £9,300,000). However, imports of motor vehicles for the transport of persons (excluding buses) were temporarily liberalised by a decree of March 1979. As regards tariffs, the 1970 Agreement with Spain provides for a 25 per cent reduction in the Spanish customs tariff for Community products. Following temporary reductions introduced in April 1980, the duties applied to EEC vehicles are 38 per cent and 29.4 per cent (compared with 48.9 and 37.4 for nonmember countries) depending on the number of seats. As far as the Commission is aware, no other barrier is applied by Spain to impts of cars from the Community. Subject to any transitional arrangements, all customs duties and quantitative restrictions still existing between Spain and the other Member States would have to be removed upon Spain's accession. (In their question the Members had referred to the concern expressed by BL's Sir Michael Edwardes about the level of imports of cars from Spain into the Community and the"virtual prohibition" by Spain of imports of his company's cars).

Greek horse trading — Antoinette Spaak (Ind/Bel) WQ 1245/80

The Commission has formally asked the Italian and Greek governments to examine allegations of cruel practices in the export of horses — including deliberate mutilation by breaking legs and blinding — because of an old Greek law prohibiting the export of healthy horses. The Italian government has assured the Commission that it has taken measures to ensure strict control of this trade and respect for Community rules. The communication to the Greek government was despatched recently and the Commission are awaiting a reply.

Guernsey tomatoes — Michael Welsh (Dem/UK) WQ 1250/80

The UK Government is responsible for relations between the Channel Islands and the Community and their comments have been requested on a report that the Guernsey Island Parliament is considering a special export subsidy for its tomato growers involving a guaranteed deficiency payment. The Island authorities are entitled to maintain their own methods of supporting their agricultural producers provided that the principles of free movement of products and normal conditions of competition are respected. The island authorities may not, therefore, grant aids on exports to the United Kingdom or other Member States in breach of the rule concerning respect of normal conditions of competition, The island is also specifically prohibited from granting aids on exports to other Member States or third countries which are in excess of the refunds, compensatory amounts or other payments fixed under Community rules for exports from the United Kingdom.

Potato imports — Neil Blaney (TCD/Irl) WQ 1253/80

In the absence of a common organisation for the market in potatoes, the Commission is unable to compensate for any losses suffered by farmers as a result of imports from outside the Community. During the first half of 1980 there were surpluses of potatoes in a number of Member States owing to large stocks from the 1979 harvest and warm weather during the winter which encouraged consumption of other vegetables. Imports from outside the Community were at normal levels. Potatoes are imported during the Spring and are mainly new potatoes in which the EEC has a large deficit.

No aid for Bolivia — Daniel Percheron (Soc/Fr) WO 1196/80

All Community aid which might benefit Bolivia and the military junta installed in July 1980 has been suspended. The Commission deplores and condemns the coup d'état, the more so because it abruptly ended the successful development towards democracy.

Energy saving — Vincent Ansquer (EPD/Fr) WQ 1293/80

The eleventh session of the World Energy Conference confirmed the Commission's assessment of the long term outlook for the world energy market. Although physical resources are abundant, the terms of future supply — particularly of oil — will be unfavourable to consumers. It is essential to make more effort to save energy and develop substitute forms (particularly coal and nuclear). To be effective this effort requires strengthened international co-operation, particularly to help the developing countries overcome the difficulties they are facing as a result of high oil prices.

Animal anabolics — Manlio Cecovini (Lib/It) WQ 1256/80

Appropriate and urgent proposals concerning the use of anabolics (oestrogens) for fattening cattle have been presented by the Commission. Two proposals for Directives on the harmonisation of legislation on veterinary medicinal products, which provide in particular for the introduction of restrictions on the distribution of substances with hormonal activity, have remained blocked by the Council since the end of 1978. Controls in Member States on the manufacture and distribution of anabolics, as well as on treated animals live or slaughtered, differ and the Commission will present proposals for the harmonsiation of control.

France on-the-spot — ___Thomas van der Vring (Soc/Ger) WQ 1318/80

The Commission has informed the French government that, with effect from the financial year 1980, outstanding payments from the European Regional Fund for industrial projects in respect of which its representatives have not been permitted to take part in on-the-spot checks and which have not, therefore, been subject to verification, will be suspended. The Commission regards the refusal of the French authorities to allow Commission officials to take part in on-the-spot checks of industrial undertakings as an infringement of the EEC Treaty. The Commission is doing its utmost to put an end to this untoward practice which, if continued, will result in the matter being brought before the Court of Justice.

Citizens Band — Vincent Ansquer (EPD/Fr) WQ 1299/80

The possibility of sending the Council a proposal for the harmonisation of provisions relating to Citizens' Band radio is being considered by the Commission. Technical provisions governing the use of Citizens' Band radiotelephone transmitterreceivers have been harmonised since 1977 by a Recommendation of the European Conference of Postal and Tele-Communications Administrations which lays down common rules for radiotelephone, licensing, technical S characteristics and type-approval and the frequencies that can be used by the general L E public. It is for Member States telecommunications administrations to implement these recommendations.

Ultra horrid milk — Robert Moreland (Dem/UK) WQ 1233/80

Because of concern for public health and the need to prolong the keeping qualities of the product, most milk sold to domestic consumers has been subjected to one of three methods of heat treatment - pasteurisation, sterilisation or Ultra Heat Treatment (UHT). The Commission understands that in the United Kingdom some 95 per cent of liquid milk sold to domestic consumers has undergone one of these forms of heat treatment and that further restrictions on the remaining possibilities to market milk in its raw state are being introduced by the UK authorities. Lower temperatures used in the pasteurisation process result in a product which has a limited shelf life and requires more sophisticated storage and distribution arrangements than sterilised or UHT (Long Life) milk. As most milk sold to domestic consumers is "heat treated" in one way or another, the use of this designation alone would not serve to distinguish pasteurised milk (popularly termed fresh milk by many consumers) from milk which has undergone one or other methods of treatment. The Commission agrees that it is desirable for containers to indicate clearly whether the milk is pasteurised, sterilised or UHT. The best interests of the Community diary sector and consumers of milk are served by making available as wide a range as possible of different types of milk on the retail market. (Mr Moreland referred to UHT milk as "Ultra horrid taste".)
