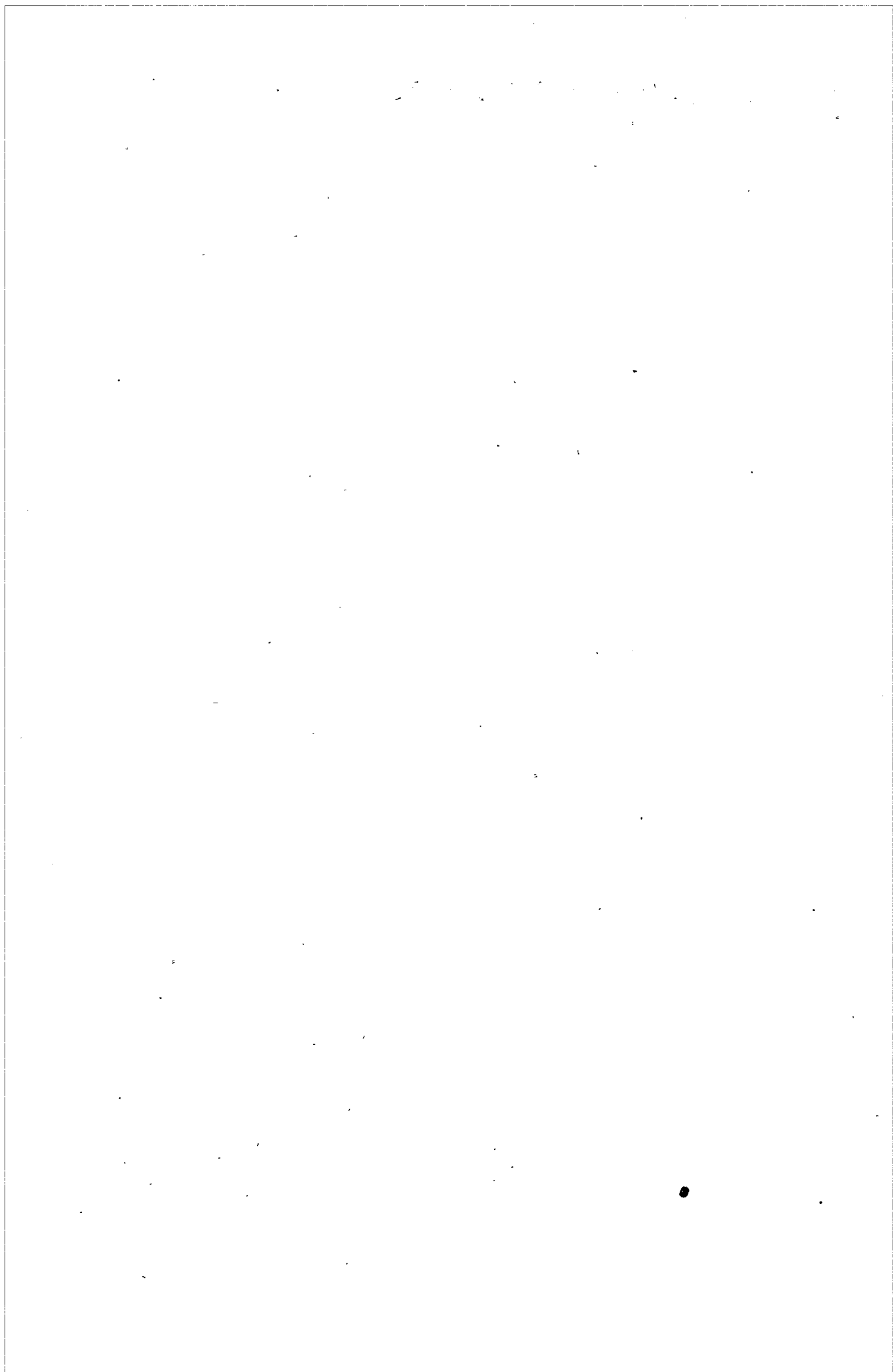

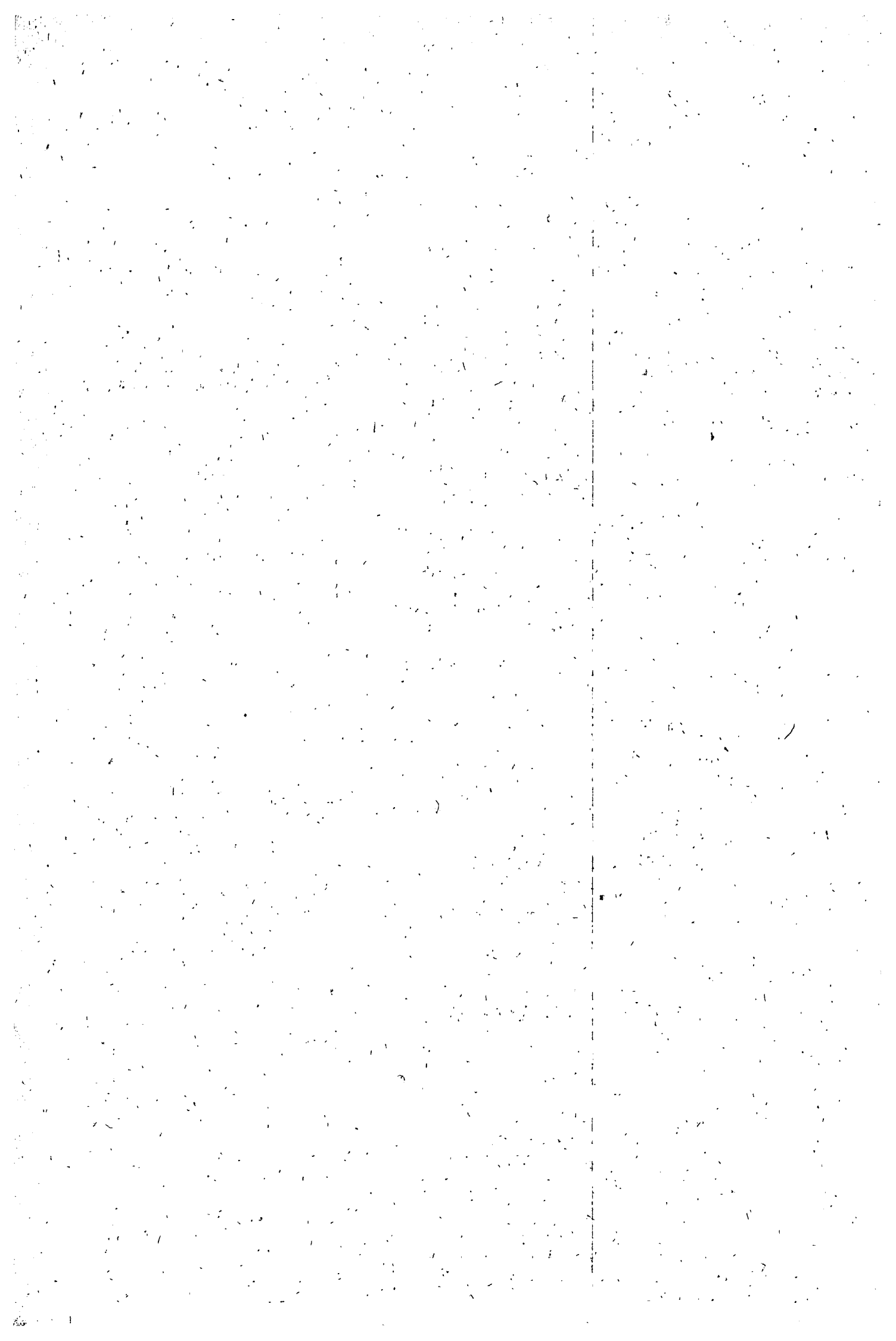

EXPLANATORY MEMORANDUM

The purpose of this proposal is to ensure that the granting of production refunds on maize groats and meal used for brewing, provided for in Council Regulation (EEC) No 1125/78, is taken into account in calculating the variable component of the import levy applicable on this product.



COUNCIL REGULATION (EEC)

amending Regulation (EEC) No 2744/75 on the import and export system for products processed from cereals and from rice

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals ¹⁾, as last amended by Regulation (EEC) No 1125/78 ²⁾, and in particular Article 11(3) thereof,

Having regard to Council Regulation (EEC) No 2742/75 of 25 October 1975 on production refunds in the cereals and rice sectors ³⁾, as last amended by Regulation (EEC) No 1127/78 ⁴⁾, and in particular Article 4(2) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 1125/78 of 22 May 1978 amending Regulation (EEC) No 2727/75 provides for production refunds for maize groats and meal used in the manufacture of beer; whereas account should be taken of the production refund in calculating the variable component of the import levy applicable to maize groats and meal falling under tariff heading No 11.02 A V a) 1.

Article 1

The text of paragraph 1 of Article 5 of Regulation (EEC) No 2744/75 shall be replaced by the following:

"When calculating the variable component of the levy applicable to the products listed in Annex I under tariff heading No or subheading 11.02 A V, 11.04 C, 11.08 A, 11.09, 17.02 B II and 23.03 A I and intended at the time of importation for the same uses as those laid down for the granting of production refunds on:

- potato starch,
- common wheat, maize and broken rice used in the Community for the manufacture of starch,
- maize used for the manufacture of groats and meal used by the brewing industry,

the production refunds granted shall be taken into account."

Article 2

This Regulation shall enter into force three days after its publication in the Official Journal of the European Communities.

It shall be applicable from 2 June 1978.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
