#### 5.2 KETHOD OF CALCULATION

The cost of the compensatory allowance is calculated as follows:

15,000 Adult Bovine Units at 52,5 u.a. per unit gives a total cost of 787,500 u.a. The reimbursement rate of 35% gives a cost to EAGGF of 275.000 u.a. per year. However, as this amount is only 0,2 to 0,3% of the future estimates for Post 8103, it is not necessary to modify these estimates.
