

#### Emplanatory Hemorandum

Until 17 May 1976, argol was governed by Regulation (EEC) No 816/70 laying down additional provisions for the common organization of the market in wine. Since this product was excluded from the said basic wine Regulation by Regulation (EEC) No 1160/76, it should be inserted in the Annex to Regulation (EEC) No 827/68, known as the "remnant Regulation".

The application of this Regulation has no financial implications for the Community budget.

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission,

Having regard to the Opinion of the European Parliament,

Whereas Council Regulation (EEC) N° 816/70 of 28 April 1970 laying down additional provisions for the common organization of the market in vine 1 was last amended by Regulation (EEC) N° 11 $^{\circ}$ )/76 $^{\circ}$  whereas one such amendment excluded

HAS ADOPTED THIS REGULATION:

#### Article 1

The following product is, hereby added to the Annex to Regulation (EEC) No 827/68 in the numerical order of the Common Customs Tariff:

23-05	Wine lees ; argol : B. Argol

#### Article 2

This Regulation shall enter into force on 1 September 1976.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
