Money for Jobs, not Surpluses

On 6 November, Parliament is expected to adopt major amendments to the draft 1981 EEC budget, reinstating much of the money for the regional fund, social fund, energy and research and development aid which had earlier been cut from the Commission's proposals by the Finance Ministers of the Nine meeting in the Council of Ministers. At the same time a resolution highly critical of the Council's whole approach to EEC spending is likely to be passed overwhelmingly. This will condemn the Council for profligacy in agriculture whilst ignoring the pressing needs of the Community in other fields.

Speakers from all sides of the House in July were highly critical of the Commission's preliminary draft which had included far higher figures for non-agricultural spending. Parliament's spokesman Pietro Adonnino (EPP/It), had called it "transitional" and Budget Commissioner Christopher Tugendhat had himself agreed that the proposals had been framed against a background of severe financial constraints. By making savage cuts the Council had now rendered this budget "simply unacceptable", said Mr Adonnino.

Where the money comes from

In 1980 the Community's revenue for financing the Budget is expected to come from "own resources"* as follows:

Strategy for 1981

What could well emerge as a consensus view of Parliament was voiced by European Democratic Group spokesman John M. Taylor during the October part-session (14 October). Forecasting major amendments by Parliament to non-agricultural spending he said "In 1981 the Parliament must so order this budget that when the farm ministers meet next spring they will do so with their heads firmly pressed against the VAT ceiling, the present limits of the Community's own resources. If they do that, and if they perceive a real need to spend more money on some agricultural purpose then they will have to make a corresponding economy in some other agricultural sector — and that is a state of affairs that the Commission has always wished to see."

How the Budget Compares

That the Community budget is still relatively modest is evident when it is seen in relation to Member States' public expenditure:

The implications are clear: the Community's own resources are rapidly becoming exhausted. Only a small fraction of the 1% of VAT rate now remains unused and this could well prove insufficient during the coming year. From 1975 to 1979 Community revenue (customs duties, levies and VAT) increased at an annual rate of 12.5%; but in the same period agricultural market guarantee expenditure increased from about £2,800m (equivalent) in 1975 to £6,500m, an average annual increase of 23%, or nearly twice the rate for total (continued on back page)

THE EEC BUDGET FOR 1981

revenue. In 1981 available revenue will total about £13,000m (equivalent). The Commission in drawing up the preliminary draft budget for 1981 allowed about £346m for contingencies, including the 1981 agricultural price review, harvest uncertainties and other measures. By reducing proposals for nonagricultural expenditure, the Council hoped to increase this latitude to about £856m. Parliament, in restoring these cuts and making other amendments, will substantially decrease this margin. In the words of one member of the Agriculture Committee: "The time when the Community could simply spend its way out of politically embarrassing decisions has come to an end" ... "there simply may not be sufficient appropriations available to operate the CAP throughout 1981, and in particular to provide for adequate price adjustments and any additional measures required".

Following amendments by Parliament on 6 November the draft budget returns to the Council, to re-emerge in Parliament during the December part-session. It remains to be seen whether Luxembourg Council President-in-Office Jacques Santer's promise of "sincere comprehension" of Parliament's position will be borne out by the Councils' attitude during the autumn budget dialogue with Parliament.

Replies to Members' Questions

Scrap landing cards – Brian Hord (Dem/ UK) WQ 364/80

The Commission is recommending Member States to end the practice of requiring the citizens of Community countries to fill in "landing cards" on inter-Community travel.

Inland postage rates should apply throughout the Community. At present domestic rates for letters not exceeding 20 grams and postcards, which account for 80 per cent of all postal items, apply within the six original Member States and between Denmark and the Federal Republic of Germany. Only Denmark has so far acted upon a Commission recommendation of May, 1979 that Member States charge domestic rates for postal items of the categories between themselves. All Member States except the UK ("because of declining revenue") are preparing to introduce domestic rates for postal traffic with Denmark.

Working at home – Ken Collins (Soc/ UK) WQ 727/80

Home working was discussed at a recent conference in Manchester in the light of the development of new technologies. The Conference felt that the application of these technologies, and of microchips in particular, should not lead to an increase in home working for women as this could lead to women once again finding themselves tied to the home.

Traffic noise – John O'Connell (Soc/Irl) WQ 336/80

Work is well advanced in the Commission on a proposal to reduce the permissable noise level of motor vehicles. The aim is for a measure to be adopted to lower noise emission levels for all types of motor vehicle to below 80dB (A) by 1985. Development work by manufacturers on quieter lorries is well advanced in both Britain and Germany, reports the Commission.
