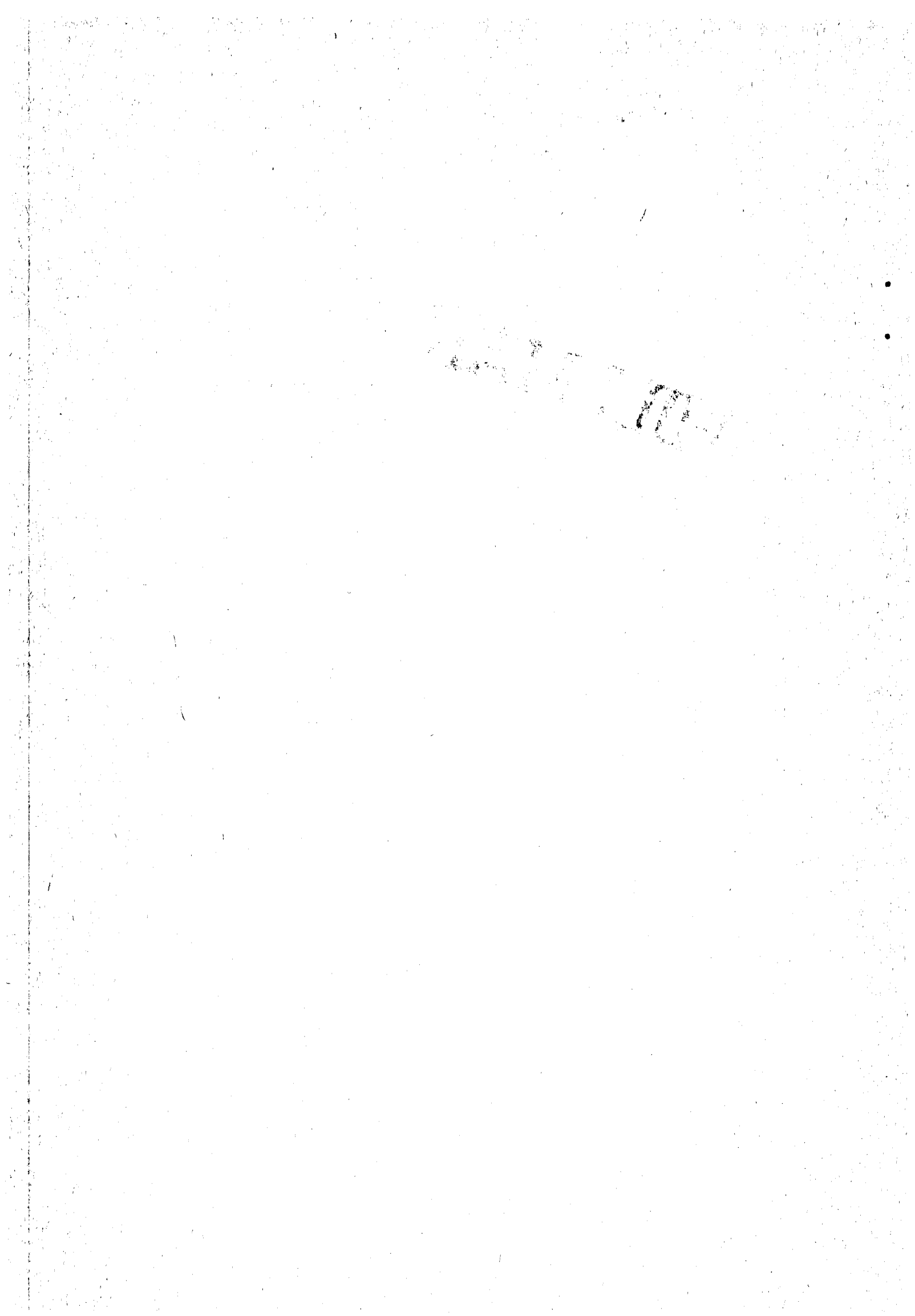

amending Regulation (EEC) No 2824/72 laying down general  
rules for the financing of interventions by the Guarantee  
Section of the European Agricultural Guidance and Guarantee  
Fund

(submitted to the Council by the Commission)



EXPLANATORY MEMORANDUM

1. Article 3 of Regulation (EEC) N° 729/70 lays down general rules for the financing of interventions by the Guarantee Section of the European Agricultural Guidance and Guarantee Fund. They are contained in Regulation (EEC) N° 2824/72 which lists, in its Annex, the measures which are interventions intended to stabilize agricultural markets.

This Annex, as last amended by Regulation (EEC) N° 2917/76 of 23 November 1976, must be brought up to date because, in the meantime, several measures have been adopted or extended.

2. This proposal of Regulation does not create a new type of expenditure.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 729/70 of 21 April 1970 on  
the financing of the common agricultural policy<sup>1</sup>, as last amended by  
Regulation (EEC) No 2788/72<sup>2</sup>, and in particular Article 3 (2) thereof,

Having regard to the proposal from the Commission,

Whereas the Annex to Council Regulation (EEC) No 2824/72 of 28 December  
1972 laying down general rules for the financing of interventions by the  
Guarantee Section of the European Agricultural Guidance and Guarantee  
Fund<sup>3</sup>, as last amended by Regulation (EEC) No 2917/76<sup>4</sup>, lists the measures  
which can be defined as intervention intended to stabilize the  
agricultural markets within the meaning of Article 3 (1) of Regulation  
(EEC) No 729/70; whereas, since the last amendment to the said Annex,  
some measures have been adopted or extended which are to be considered, as  
regards the financing of the common agricultural policy, as intervention  
intended to stabilize the agricultural markets; whereas that Annex should  
therefore be amended,

HAS ADOPTED THIS REGULATION :

Sole Article

The Annex to Regulation (EEC) No 2824/72 is amended as follows :

1. In Section III, "Milk and milk products" :  
the following points, together with the relevant footnote, are added:  
"14. The non-marketing premiums for milk and milk products and the premiums for the conversion of dairy herds to meat production provided for in Article 1 of Regulation (EEC) No 1078/77<sup>1</sup>.  
15. The co-responsibility levy and the measures to expand the markets for milk products pursuant to Articles 1 and 4 of Regulation (EEC) No 1079/77."
2. In Section VI, "Beef and veal", points 3 and 4 are amended to read as follows :  
"3. The calving premiums provided for in Article 4 of Regulation (EEC) No 464/75 and Article 1 of Regulations (EEC) Nos 620/76 and 871/77.  
4. The premiums for the slaughter of certain adult bovine animals provided for in Article 1 of Regulation (EEC) No 870/77."
3. In Section VII, "Pigmeat", the following point is added :  
"3. Private storage aid under Article 20 of Regulation (EEC) No 2759/75."
4. In Section VIII, "Fruit and vegetables" :
  - a) points 7 and 8 are amended to read as follows :  
"7. The production aid for tinned pineapple provided for in Article 1 of Regulation (EEC) No 525/77.  
8. The compensatory amounts applicable in certain intra-Community trade in tomato concentrates and peeled tomatoes provided for in Article 1 of Regulation (EEC) No 522/77."

"(1) EAGGF financing : 60% by the Guarantee Section and 40% by the Guidance Section."

b) the following point is added :

"9. The financial compensation to encourage the marketing of products processed from lemons provided for in Regulation (EEC) No 1035/77.

5. In Section IX "Wine", points 1 and 4 are amended as follows :

"1. Aid for the private storage of table wines and grape must provided for in Articles 5, 5a and 6 of Regulation (EEC) No 816/70.

4. The distillation of wines provided for in Articles 6b, 6c, paragraph 2, line 2, and 6d, and in Articles 7, 24a and 24b of Regulation (EEC) No 816/70."

6. In Section X, "Raw tobacco", the following point is added :

"3. Special aid per hectare for tobaccos of the Beneventano variety, as provided for in Article 4 of Regulation (EEC) No 339/77.

7. In Section XII D, "Silkworms", point 2 is amended to read as follows :

"2. The additional aid provided for in Article 1 of Regulation (EEC) No 867/77."

This Regulation shall be binding in its entirety and directly applicable in all Member States
