Proposal for a COUNCIL REGULATION (EEC)

amending, for the second time, Regulation (EEC) N° 4198/88 allocating,
for 1989, catch quotas between Member States for vessels fishing in
Swedish waters

(presented by the Commission)

EXPLANATORY MEMORANDUM

By Regulation (EEC) No 4198/88 the Council has allocated among Member States the shares available for 1989 to Community vessels fishing in Swedish waters in the Baltic Sea.

Following consultations between the Community and Sweden, the latter has offered the Community a supplementary catch quota of herring for 1989 without seeking compensation from the Community neither for 1989 nor for 1990.

The purpose of the present regulation is to divide between Member States this supplementary catch quota in Swedish waters in the Baltic Sea for 1989. The distribution is based on the principles which were applied to the allocation of quotas in 1983.

THE COUNCIL OF THE EUROPEAN COMMUNITY,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) N° 170/83 of 25 January 1983
establishing a Community system for the conservation and management of
fishery resources (1), as amended by the Act of Accession of Spain and
Portugal (2), and in particular Article 11 thereof,

Having regard to the proposal from the Commission,

Whereas Regulation (EEC) N° 4198/88 (3), as amended by Regulation (EEC)
N° 297/89 (4), allocates for 1989 catch quotas between Member States for
vessels fishing in Swedish waters;

Whereas the Community and the Kingdom of Sweden have held further
consultations regarding an additional catch quota of herring in the Swedish
fishing zone for Community vessels in 1989;

Whereas it is for the Community, pursuant to Article 3 of Regulation (EEC)
N° 170/83, to determine the conditions subject to which this additional
catch quota may be used by Community fishermen;

Whereas, to ensure efficient management of the catch possibilities
available, they should be shared among the Member States by means of quotas
in accordance with Article 4 of the said Regulation;

HAS ADOPTED THIS REGULATION :

Article 1

The figures in the Annex to Regulation (EEC) N° 4198/88, as amended, relating to herring in ICES Division IIIId are hereby replaced by those set out in the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COMPETITIVENESS AND EMPLOYMENT IMPACT STATEMENT

The object of the proposed Regulation is to divide between Member States the supplementary catch quota in Swedish waters in the Baltic Sea for 1989, as notified by Sweden.

The proposed Regulation will not involve undertakings in any particular obligations except for the evident respect of the relevant fisheries regulations in force.

RAPPORT DE L'IMPACT SUR LA COMPETITIVITE ET L'EMPLOI

L'objet du Règlement proposé est de répartir entre les Etats Membres le quota de capture supplémentaire dans les eaux suédoises en Mer Baltique pour 1989, comme notifié par la Suède.

Le Règlement proposé n'implique pas d'obligation particulière excepté, évidemment, le respect des règlements respectifs de pêche en vigueur.

BERICHT ÜBER DIE AUSWIRKUNGEN AUF WETTBEWERBSFÄHIGKEIT UND BESCHÄFTIGUNG

Gegenstand der vorgeschlagenen Verordnung ist es, die zusätzliche Fangquote in schwedischen Gewässern in der Ostsee für 1989, wie notifiziert durch Schweden, aufzuteilen unter den Mitgliedstaaten.

Die vorgeschlagene Verordnung bringt keine besonderen Verpflichtungen für die Unternehmen mit sich, ausgenommen die Respektierung der geltenden einschlägigen Fischereibestimmungen.
