EXPLANATORY MEMORANDUM

Subject: Proposal for a Council Regulation (E C) amending Regulation (EEC) No 404/93 as regards the volume of the annual tariff quota for the import of bananas into the Community following the accession of Austria, Finland and Sweden.

The purpose of this Regulation is to amend the volume of the tariff quota fixed by Regulation (EEC) No 404/93 for the import of third country bananas and ACP non traditional bananas to take account of the needs of the new Member States. Those needs have been assessed on the basis of figures for average net imports during the last three years for which figures are available (1991-93). The adjustment involves 353,000 tonnes (net weight).

This Regulation should be published by 1 January 1995.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community,

Having regard to the Act of Accession of the Republic of Austria, the Kingdom of Sweden and the Republic of Finland to the European Union⁽¹⁾, and in particular Article 169(2) thereof,

Having regard to Council Regulation (EEC) No 404/93 of 13 February 1993 on the common organization of the market in bananas⁽²⁾, as amended by Commission Regulation (EC) No 3518/93⁽³⁾,

Having regard to the proposal from the Commission⁽⁴⁾,

Whereas Regulation (EEC) No 404/93 provides for the opening of an annual tariff quota for imports of third country bananas and non traditional ACP bananas; whereas, following the accession of the Republic of Austria, the Kingdom of Sweden and the Republic of Finland to the European Union, account should be taken of the banana needs of these new Member States, which have been assessed as 353,000 tonnes on the basis of the net average quantities of bananas imported by those countries over the period 1991-93, the last three years for which figures are available; whereas, therefore, a volume of the tariff quota provided for in Article 18 of Regulation (EEC) No 404/93 should be adjusted;

HAS ADOPTED THIS REGULATION:

Article 1

In the first subparagraph of Article 18(1) of Regulation (EEC) No 404/93 the words "two million tonnes (net weight)" is hereby replaced by 2,553,000 tonnes (net weight)".

Article 2

This Regulation shall apply from 1 January 1995.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
