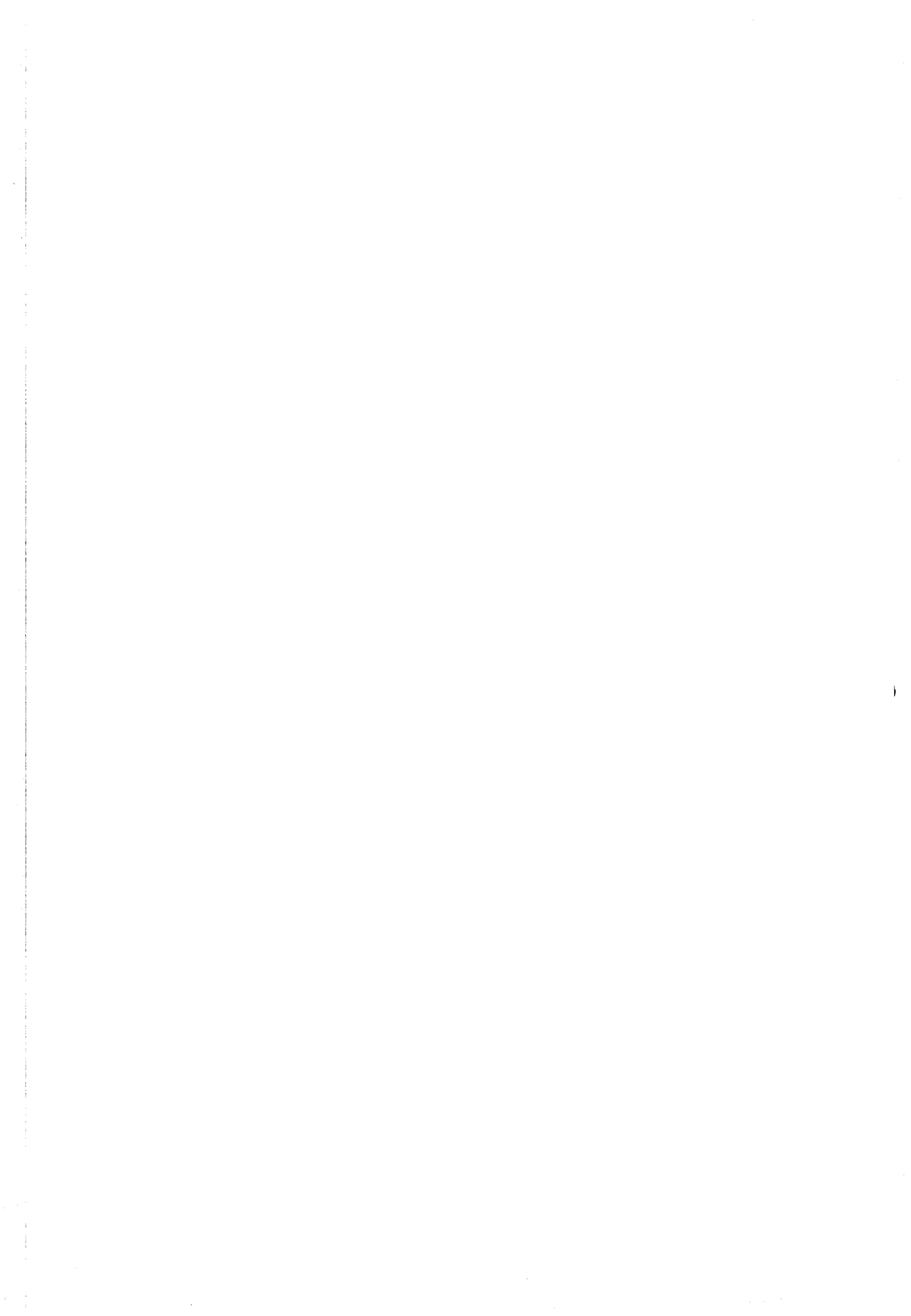

EXPLANATORY MEMORANDUM

It will not be possible to fix prices for fishery products in time for the 1981 fishing year (January 1)

In order to maintain continuity, it is proposed that prices for 1980 be kept valid until the date of fixing prices for the said fishing year.

Financial consequences : the estimated expenses are identical to those of 1980 pro rata temporis.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 100/76 of 19 January 1976 on the
common organization of the market in fishery products¹, as last amended by
Regulation (EEC) No ², and in particular Articles 9(4), 14(5) and
16(5) thereof,

Having regard to the proposal from the Commission,

Whereas the guide prices, intervention prices and the Community producer price were
fixed for the 1980 fishing year by Council Regulations (EEC) Nos 2813/79³,
2814/79⁴, 2815/79⁵ and 2816/79⁶;

Whereas it is not possible to fix these prices in time for the 1981 fishing year;

Whereas, in order to maintain continuity, it is necessary to retain the prices
applicable in 1980 for a limited period in the 1981 fishing year, until
prices are fixed for that year,

HAS ADOPTED THIS REGULATION:

Article 1

The prices fixed in Regulations (EEC) Nos 2813/79, 2814/79, 2815/79 and 2816/79 shall remain valid until the date of entry into force of the Regulations fixing the prices for 1981.

Article 2

This Regulation shall enter into force on 1 January 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
