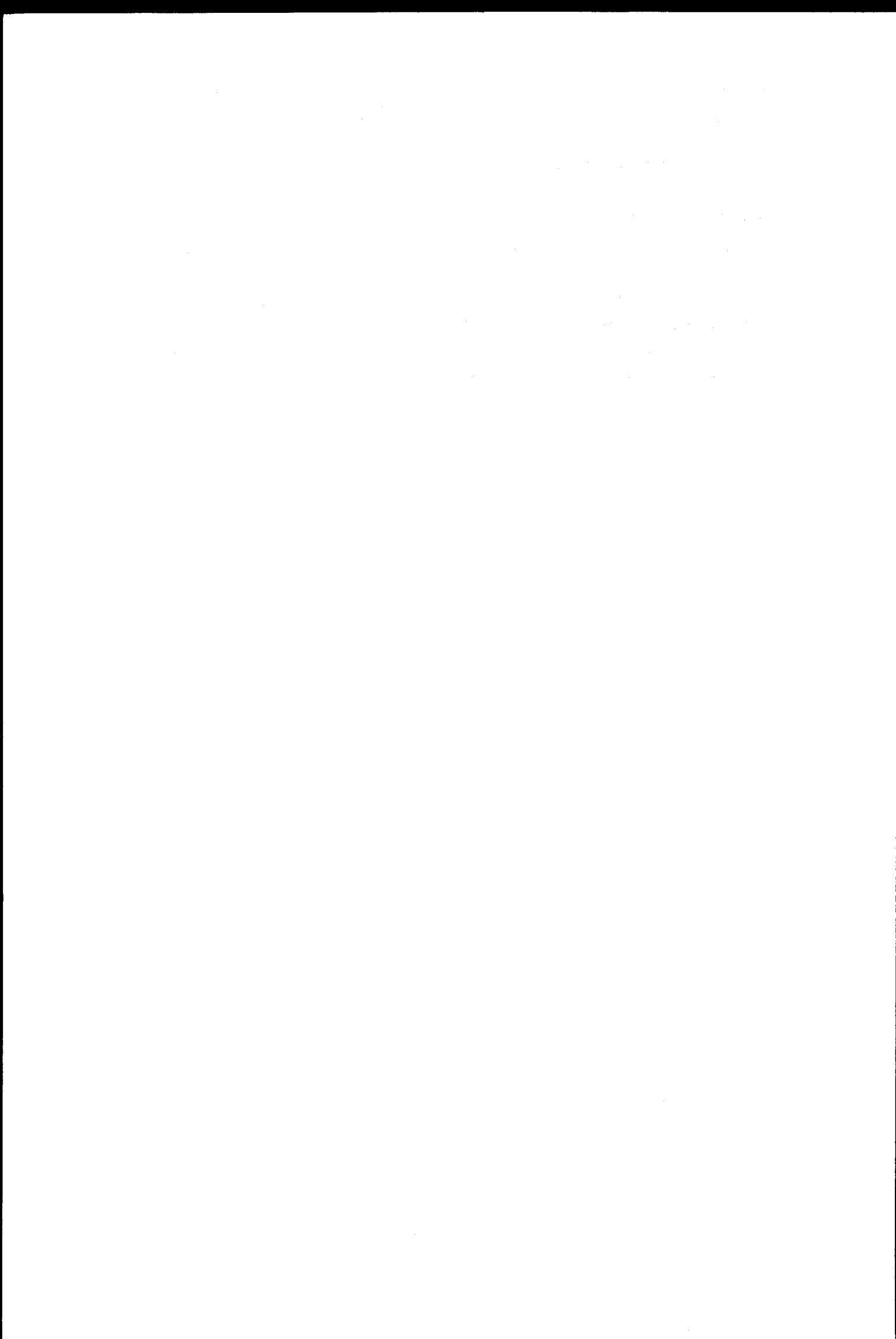

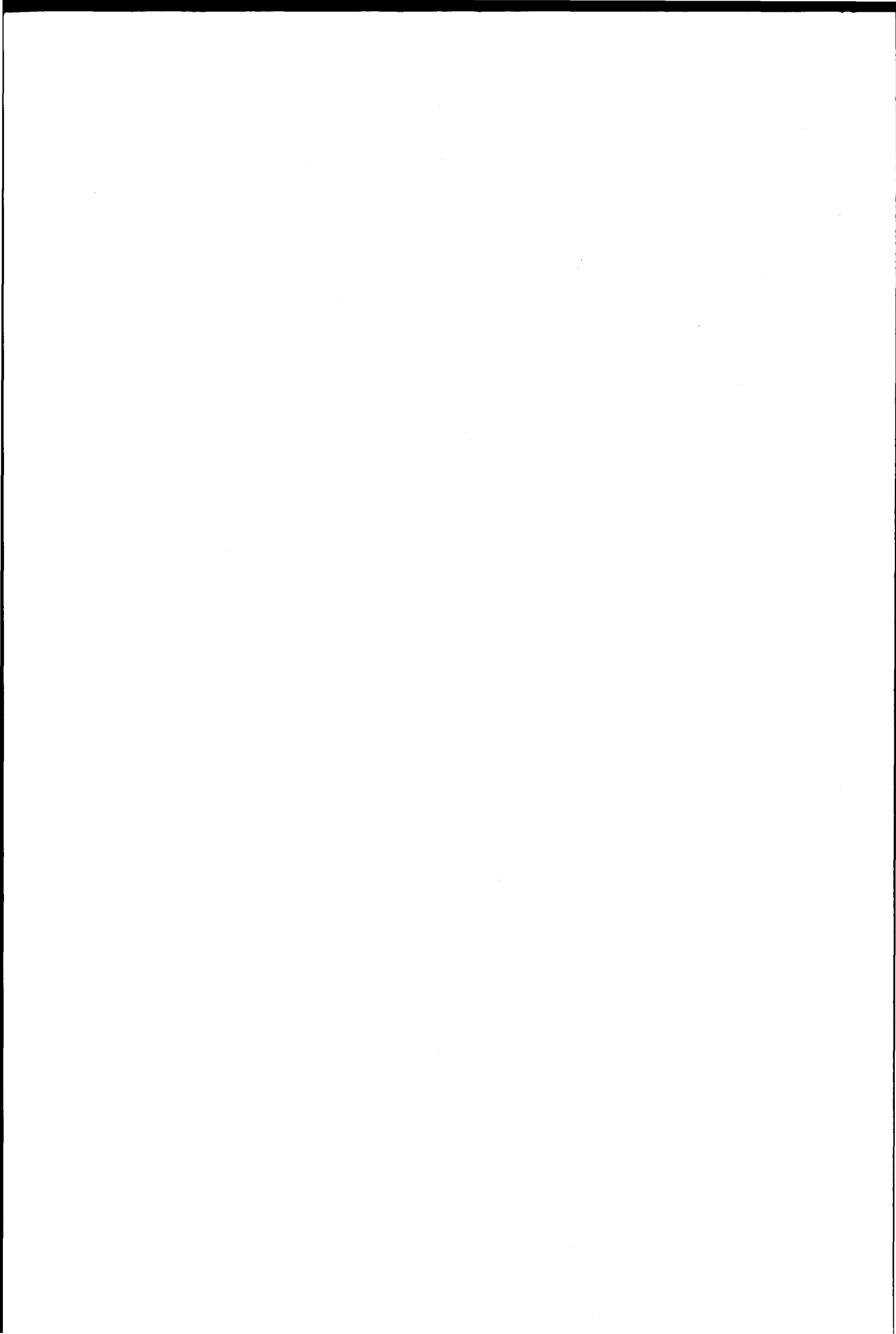
Subject: Relations between the European Community and Portugal
